
NOW, THEREFORE, for good and valuable consideration, receipt of which is hereby acknowledged, Secured Party hereby:

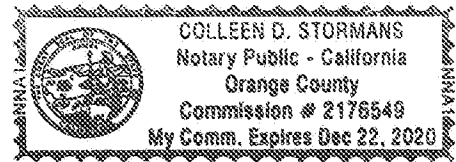

RELEASE OF SECURITY INTEREST

KNOW ALL MEN BY THESE PRESENTS that HARTFORD FIRE INSURANCE COMPANY, a Connecticut corporation (hereinafter "HFI"), for good and valuable consideration, hereby (i) acknowledges and agrees that all obligations of XDimensional Technologies, Inc., a California corporation (the "Company"), under that certain Ninth Amended and Restated Convertible Demand Note, dated as of May 13, 2009, in favor of HFI in the original principal amount of \$15,000,000 (as amended by that certain Allonge to Amended and Restated Convertible Demand Note, dated as of June 29, 2009) are hereby released, discharged and forgiven, (ii) releases and discharges any and all security interests in the assets of the Company including, without limitation, those granted pursuant to the terms of that certain Security Agreement, dated as of July 5, 2007 and as subsequently amended by the First Amendment to Security Agreement, dated as of November 29, 2008, through the Ninth Amendment to Security Agreement, dated as of May 13, 2009, and (iii) authorizes the Company to file any and all UCC termination statements or similar documents as are deemed reasonably necessary by the Company to evidence the releases contemplated by clauses (i) and (ii) above.
