**TERMINATION OF TRADEMARK SECURITY AGREEMENT  
AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**

**THIS TERMINATION OF TRADEMARK SECURITY AGREEMENT AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this "**Release**") is made as of March 1, 2021, by and between CASAMBA, LLC., a Delaware limited liability company ("**Casamba**") and HEALTHWYSE LIMITED LIABILITY COMPANY, a Delaware limited liability company ("**Healthwyse**", and collectively with **Casamba**, the "**Grantors**") and WEBSTER BANK, NATIONAL ASSOCIATION, in its capacity as Collateral Agent (in such capacity, the "**Agent**") under that certain Trademark Security Agreement dated as of October 13, 2016 by and among the Grantors and the Agent (as amended, the "**Trademark Security Agreement**");

**WHEREAS**, pursuant to the terms and conditions of the Trademark Security Agreement, Grantors granted to Agent on behalf of the secured parties a continuing security interest in and to, and lien on, all of Grantors' respective rights, title and interest to and under certain Trademark Collateral (as defined in the Trademark Security Agreement) including, without limitation, the Trademark Collateral set forth on Schedule A attached hereto (collectively, the "**Trademarks**");

**WHEREAS**, the Trademark Security Agreement was recorded with the U.S. Patent and Trademark Office ("**USPTO**") on October 27, 2016 at Reel/Frame 5908/0697 on October 27, 2016;


**WHEREAS**, Agent desires to terminate and release the Trademark Security Agreement and all such security interests in and liens on the Trademarks;

**NOW, THEREFORE**, for and in consideration of the foregoing, and other good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, agent on behalf of itself and the secured parties, hereby releases and terminates the liens granted in the Trademarks under the Trademark Security Agreement, and the Guaranty and Security Agreement (as defined in the Trademark Security Agreement), and relinquishes unto Grantors the continuing security interest in, and lien on, the Trademarks and otherwise assigns, grants and conveys to Grantors, without recourse, any and all right, title and interest the Agent or the secured parties may have in, to or under the Trademarks in order to revest in Grantors full and unencumbered title to said Trademarks. Agent hereby authorizes the Grantors or the Grantors' designee, at the Grantors' sole cost and expense, to record this Release with the USPTO.
