## RELEASE OF SECURITY INTEREST IN TRADEMARKS


This RELEASE OF SECURITY INTEREST IN TRADEMARKS is made as of December 17, 2020, by and between ADVANCED WEB TECHNOLOGIES, INC., a Delaware corporation (the "Company" and successor by merger to Advanced Web Technologies, LLC, a Minnesota limited liability company), CITATION HEALTHCARE LABELS, LLC, a Delaware limited liability company ("Citation"), ADVANCED WEB TECHNOLOGIES ILLINOIS, INC., a Delaware limited liability company ("AWT IL"; and together with the Company and Citation, the "Borrowers"), ADVANCED WEB TECHNOLOGIES HOLDING COMPANY, a Delaware corporation ("Holding"; and together with the Borrowers, each a "Debtor" and collectively, the "Debtors") and JOHNSON BANK, as administrative agent for the Benefited Parties (as defined in the Security Agreement) (in such capacity, the "Secured Party"), with reference to the following facts:

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of August 17, 2018, by and among the Debtors and the Secured Party, the Debtors granted a continuing security interest to the Secured Party in all of the Debtors' right, title, and interest in, to and under the following (whether existing or created or acquired after August 17, 2018): the Trademarks the Debtors registered with a United States Governmental Authority, or for which the Debtors had filed applications, which are referred to in Schedule 1 annexed hereto; and all the goodwill, products and proceeds of the foregoing (collectively referred to as the "Trademark Collateral"), which was recorded at the U.S. Patent and Trademark Office on September 10, 2018 at Reel/Frame: 6440/0314).

WHEREAS, the Secured Party desires to release any security interest it might have in the Trademark Collateral and reassign any and all rights, title and interests in the same to the Debtors.

NOW, THEREFORE, for valuable consideration, the receipt and adequacy of which is hereby acknowledged: the Secured Party hereby (i) unconditionally terminates, releases and discharges any and all security interest, right, title or other interest it may have in the Trademark Collateral, and (ii) reassigns, grants and conveys to the Debtors, without any recourse, any and all of the Secured Party's right, title and interest in and to the Trademark Collateral, along with any goodwill in the Trademark Collateral therein that the Secured Party may have acquired.
