RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY

THIS RELEASE OF SECURITY INTEREST IN INTELLECTUAL PROPERTY (this "Release") is made this 1st day of March, 2021, by PACIFIC WESTERN BANK, a California state-chartered bank, in its capacity as collateral agent for the Secured Parties (together with its successors and assigns in such capacity, the "Agent").

WHEREAS, reference is made to the Intellectual Property Security Agreement dated as of August 12, 2019, and recorded with the United States Trademark and Trademark Office on August 12, 2019, at Reel 006717 Frame 0934 and Reel 50032 Frame 0652 (recorded as Pacific Western Bank as Agent) (as amended, supplemented and/or modified to date, collectively, the "IP Security Agreement"), by UCIT ONLINE SECURITY INC., a corporation amalgamated pursuant to the Business Corporations Act (British Columbia) ("UCIT Online"), and STEALTH MONITORING INC., a Texas corporation ("Stealth Monitoring"), and together with UCIT Online, each a "Grantor", and collectively, the "Grantors"), in favor of Agent. Capitalized terms used herein and not otherwise defined shall have the meanings ascribed thereto in the IP Security Agreement.

WHEREAS, under the IP Security Agreement, Grantors granted to Agent, for the benefit of the Secured Parties, a security interest in all of such Grantor's rights, title and interests in, to and under the Intellectual Property Collateral (as defined in the IP Security Agreement) identified therein, including, but not limited to, the trademark registrations and patent application set forth on the Schedule attached hereto.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Agent hereby (i) terminates the IP Security Agreement, (ii) releases any and all liens on, and its security interest in and to the Intellectual Property Collateral arising under the IP Security Agreement, including, but not limited to, the trademark registrations and patent application set forth on the schedules attached hereto, and (iii) authorizes the recordation of this Release by Grantors or its designee with the United States Patent and Trademark Office.
