RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of January 29, 2021 (the “Effective Date”), is made by Bank of America, N.A., in its capacity as Collateral Agent (in such capacity, the “Collateral Agent”), in favor of CoreLogic Rental Property Solutions, LLC (f/k/a CoreLogic SafeRent, LLC) (“RPS” or, the “Grantor”).

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement, dated as of March 25, 2014, as amended and restated by that certain Amended and Restated Guarantee and Collateral Agreement, dated as of August 10, 2017, by and among the Collateral Agent, the Grantor and certain other parties thereto (as amended, supplemented or otherwise modified from time to time, the “Guarantee and Collateral Agreement”), and the Grant of Security Interest in Trademark Rights dated as of April 4, 2014 by and among the Collateral Agent and the Grantor (the “Trademark Security Agreement”), the Grantor granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in certain collateral, including a security interest in all of the Grantor's trademarks, trademark applications, and trademark registrations (other than Excluded Intellectual Property), including, without limitation, certain trademarks and trademark registrations previously owned by CoreLogic Information Resources, LLC, and transferred to RPS, as set forth on Schedule A-1 hereto (the “CLIR Transferred IP”) and those items listed on Schedule A-2 attached hereto (collectively, together with the CLIR Transferred IP, the “Trademark Collateral”); and

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on May 1, 2014 at Reel/Frame 5271/0860.


NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Guarantee and Collateral Agreement or the Trademark Security Agreement, as applicable.
2. Release. The Collateral Agent, without representation, warranty, or recourse of any kind, on behalf of the Secured Parties, hereby releases, discharges, terminates and cancels all of its security interest in the Trademark Collateral and all Proceeds of the foregoing, together with the goodwill of the business symbolized by the Trademark Collateral, arising under the Guarantee and Collateral Agreement and the Trademark Security Agreement.
3. Termination. The Collateral Agent, without representation, warranty, or recourse of any kind, on behalf of the Secured Parties, terminates and cancels the Trademark Security Agreement.
4. Governing Law. This Release shall be governed exclusively under the laws of New York.


