**CERTIFICATE OF OWNERSHIP AND MERGER

(Pursuant to Section 253 of the Delaware General Corporation Law)

RICOH PRINTING SYSTEMS AMERICA, INC., (the "*Corporation*"), a corporation incorporated on the first day of March, 1962, pursuant to the provisions of the General Corporation Law of the State of Delaware;

DOES HEREBY CERTIFY that Corporation owns 100% of the capital stock of **ANAJET, INC.** (the "*Subsidiary*"), a corporation incorporated on the sixteenth day of November, 2015 A.D., pursuant to the provisions of the California General Corporation Law, and that Corporation, by a resolution of its Board of Directors executed on the thirtieth day of April, 2020 A.D., determined to merge into itself said Subsidiary, effective as of June 1, 2020, which resolution is in the following words to wit:

WHEREAS Corporation lawfully owns 100% of the outstanding stock of Anajet, Inc., a corporation organized and existing under the laws of California, and

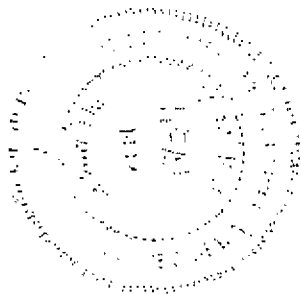
WHEREAS this Corporation desires to merge into itself said Subsidiary, and to be possessed of all its estate, property, rights, privileges and franchises.

FURTHER RESOLVED, that an authorized officer of this Corporation be and he is hereby directed to make and execute a certificate of ownership setting forth a copy of the resolution to merge said Subsidiary and assume its liabilities and obligations, and the date of adoption thereof, and to file the same in the office of the Secretary of State of Delaware, and a certified copy thereof in the office of the Recorder of Deeds of Kent County; and

FURTHER RESOLVED, that the officers of this Corporation be and they hereby are authorized and directed to do all acts and things whatsoever, whether within or without the State of Delaware; which may be in any way necessary or proper to effect said merger.
