## RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL

This RELEASE OF SECURITY INTEREST IN TRADEMARK COLLATERAL (this “*Release*”), dated as of February 26, 2021, is made by BANK OF AMERICA, N.A. (“*Lender*”), in favor of SPIRALEDGE, INC., Delaware corporation (“*Grantor*”).

### WITNESSETH

NOW, THEREFORE, for good and valuable consideration, the receipt of which is hereby acknowledged, Lender, without recourse, representation or warranty of any kind or nature, and at Grantor’s sole cost and expense, hereby releases, discharges, terminates and cancels its security interest in and to the Trademarks and the other Trademark Collateral.

Lender authorizes and requests that the Commissioner of Patents and Trademarks and any other applicable government officer record this Release.

The validity, interpretation and enforcement of this Release and any dispute arising out of the relationship between the parties hereto, whether in contract, tort, equity or otherwise, shall be governed by and construed in accordance with the laws of the State of California.



