TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS** (this “Termination and Release”) dated as of March 17, 2021, is made by Wilmington Trust, National Association, a national banking association organized under the laws of the United States, solely in its capacity as successor collateral trustee under the Collateral Trust Agreement (as defined below) (the “Collateral Trustee”), in favor of Beck Arnley Holdings LLC (“Beck Arnley”), Federal-Mogul Products US LLC, as successor to Federal-Mogul Products, Inc. (“Federal Mogul Products”), Federal-Mogul World Wide, Inc., as successor to Federal-Mogul World Wide LLC (“Federal Mogul World Wide”), Federal-Mogul Motorparts LLC, as successor to Federal-Mogul Motorparts Corporation (“Federal Mogul Motorparts”), Federal-Mogul Ignition, LLC, as successor to Federal-Mogul Ignition Company (“Federal Mogul Ignition”), Tenneco Inc., as successor to Federal-Mogul LLC (“Tenneco”), Federal-Mogul Chassis LLC (“Federal Mogul Chassis”) and Federal-Mogul Powertrain LLC (“Federal Mogul Powertrain” and, together with Beck Arnley, Federal Mogul Products, Federal Mogul World Wide, Federal Mogul Motorparts, Federal Mogul Ignition, Tenneco and Federal Mogul Chassis, collectively, the “Grantors” and, each, individually, a “Grantor”). All capitalized terms used but not defined herein have the meanings given to them in the Collateral Agreement (as defined below).

WHEREAS, each of the Grantors is a party to that certain Collateral Agreement, dated as of June 29, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), among the Grantors, the other grantors party thereto and the Collateral Trustee pursuant to which the Grantors granted a security interest to the Collateral in the Trademark Collateral (as defined below), including, but not limited to, those Trademarks listed on Schedule A hereto;

WHEREAS, pursuant to the Collateral Agreement, certain of the Grantors granted Citibank, N.A. (“Citi”), as initial Collateral Trustee, a security interest in and lien on certain Trademarks and Trademark Licenses owned by or in which such Grantors have rights (the “Trademark Collateral”) including the trademarks described the Grant of Security Interests in United States Trademarks, recorded with the USPTO on September 26, 2017 at Reel 006161 Frame 0643;

WHEREAS, pursuant to the Collateral Trustee Resignation and Appointment Agreement, dated February 23, 2018 (the “Citi Resignation and Appointment”), Bank of America, N.A. (“BANA”) became successor to Citi, as Collateral Trustee under the Amended and Restated Collateral Trust Agreement, dated as of April 15, 2014 (as so amended and as further amended, restated, supplemented or otherwise modified from time to time, the “Collateral Trust Agreement”);

WHEREAS, the Citi Resignation and Appointment was recorded with the USPTO on April 3, 2018 at Reel/Frame 006350/0784;

WHEREAS, pursuant to the Collateral Trustee Resignation and Appointment, Joinder, Assumption and Designation Agreement, dated October 1, 2018 (the “BANA Resignation and”

Appointment”), Wilmington Trust, National Association (“Wilmington”) became successor to BANA, as Collateral Trustee under the Collateral Trust Agreement;

WHEREAS, the BANA Resignation and Appointment was recorded with the USPTO on October 26, 2018 at Reel/Frame 006468/0581;

WHEREAS, Section 7.12(a) of the Collateral Agreement provides for the release of the PP&E Indenture Security Interests, including, but not limited to the grant of the security interest in and lien on the Trademark Collateral, on the date on which the Discharge of the PP&E Indenture Secured Obligations shall have occurred;

WHEREAS, the Discharge of the PP&E Indenture Secured Obligations occurred on the date hereof and the Collateral Trustee has entered into that certain Acknowledgment by Trustee, Paying Agent and, Registrar and Collateral Trustee of Discharge of Indenture, dated as of the date hereof, among The Bank of New York Mellon, London Branch, as trustee, the Collateral Trustee, as collateral trustee, The Bank Of New York Mellon, London Branch, as paying agent, and The Bank Of New York Mellon, (Luxembourg) S.A., as registrar, pursuant to which The Bank of New York Mellon, London Branch, as trustee, and the Collateral Trustee acknowledged the termination of the PP&E Indenture Secured Obligations;

WHEREAS, each Grantor has requested that the Collateral Trustee enter into this Termination and Release in order to effectuate, evidence and record the release and reassignment to such Grantor of any and all right, title and interest the Collateral Trustee may have in the Trademark Collateral; and

WHEREAS, the Collateral Trustee desires to terminate and release its security interest in the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Trustee hereby agrees:

1. Release of Security Interest. The Collateral Trustee, without recourse, representation or warranty of any kind whatsoever, hereby releases, terminates and discharges all liens and security interests the Collateral Trustee has in, to and under the Trademark Collateral.
2. Filing the Release. The Collateral Trustee authorizes and requests that this Termination and Release be filed and recorded at the USPTO at the Grantors’ sole cost and expense.
3. Counterparts; Electronic Transmission. This Termination and Release may be executed and delivered by facsimile or other means of electronic transmission and such transmission shall constitute an original for all purposes.
4. Governing Law. This Termination and Release and any claim, controversy, dispute or cause of action (whether in contract or tort or otherwise) based upon, arising out of or relating to this Termination and Release and the transactions


contemplated hereby shall be construed in accordance with and governed by the law of the state of New York, without reference to its conflict of laws principles.

5. Concerning the Collateral Trustee. Wilmington Trust, National Association is executing this Termination and Release solely in its capacity as successor Collateral Trustee under the Collateral Trust Agreement, and in acting hereunder, shall be entitled to all of the rights, privileges, immunities and indemnities granted to the Collateral Trustee in the Collateral Trust Agreement as if such rights, privileges, immunities and indemnities were set forth herein.
