RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS, dated as of March 19, 2021 (this "Release") is made by CITIZENS BANK, N.A., as administrative agent and collateral agent (in such capacity, the "Administrative Agent") for the Secured Parties (as defined in the Security Agreement referred to below) in favor of each of the Grantors listed in Schedule A attached hereto (collectively, the "Grantors").

1. Pursuant to the Security Agreement, dated as of August 28, 2017, entered into by the Grantors, each other grantor party thereto and the Administrative Agent (as amended, restated, supplemented or otherwise modified from time to time, the "Security Agreement"), Diesel Direct, LLC (formerly known as Diesel Direct, Inc.), a Massachusetts limited liability company, and the Administrative Agent entered into that certain Notice of Grant of Security Interest in Trademarks, recorded in the United States Patent and Trademark Office (the "USPTO") on August 29, 2017, at Reel 6141, Frame 0102, Value Energy Direct, LLC (formerly known as Value Energy Direct, Inc.), a Pennsylvania limited liability company, and the Administrative Agent entered into that certain Notice of Grant of Security Interest in Trademarks, dated as of December 3, 2018 and recorded in the USPTO on July 22, 2020, at Reel 7020, Frame 0988, West Direct Labs, LLC, a Colorado limited liability company, and the Administrative Agent entered into that certain Notice of Grant of Security Interest in Trademarks, recorded in the USPTO on October 2, 2017, at Reel 6167, Frame 0580, West Direct Oil, LLC, a Colorado limited liability company, and the Administrative Agent entered into that certain Notice of Grant of Security Interest in Trademarks, recorded in the USPTO on October 2, 2017, at Reel 6167, Frame 0503, West Direct Equipment Savers, LLC, a Colorado limited liability company, and the Administrative Agent entered into that certain Notice of Grant of Security Interest in Trademarks, recorded in the USPTO on October 2, 2017, at Reel 6168, Frame 0026, and Fuelloc LLC, a Delaware limited liability company, and the Administrative Agent entered into that certain Notice of Grant of Security Interest in Trademarks, dated as of August 6, 2020 and recorded in the USPTO on August 6, 2020, at Reel 7016, Frame 0540 (collectively, the "Notices of Grant"), and pursuant to the Security Agreement and the Notices of Grant, the Grantors granted to the Administrative Agent, for the benefit of the Secured Parties, a lien on and security interest in, and all right, title and interest in, to and under the trademarks listed on the attached Schedule B hereto and incorporated herein by reference (the "Trademark Collateral").

2. The Administrative Agent, without representation, warranty or recourse of any sort, hereby terminates, releases and discharges the grant of and all of its lien on and security interest in, and all right, title and interest in, to and under, the Trademark Collateral. Any right, title or interest of the Administrative Agent in, to or under the Trademark Collateral shall hereby cease and become void. This Release does not terminate, release or discharge the Administrative Agent's security interest in any intellectual property or any other asset of the Grantors other than the Trademark Collateral.

3. The Administrative Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary and requested by the Grantors to effect the release of the security interest contemplated hereby, at the Grantors' expense. The Administrative Agent hereby authorizes the Grantors or the Grantors' authorized representatives to record this Release with the USPTO.

4. This Release may be executed in any number of counterparts, each of which when so executed shall be deemed to be an original and all of which taken together shall constitute one and the same agreement. Delivery by facsimile or by electronic .pdf copy of an executed counterpart of a signature page to this Release shall be effective as delivery of an original executed counterpart of this Release.

5. This Release shall be governed by, and construed in accordance with, the laws of the State of New York.
