TERMINATION AND RELEASE OF SECURITY AGREEMENT (TRADEMARKS)

THIS TERMINATION AND RELEASE OF SECURITY AGREEMENT (TRADEMARKS) (this "**Termination**"), is dated as of March 1, 2021, and made by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as Agent under the below-defined Security Agreement, having an address at 301 Fayetteville Street, Suite 2100, Raleigh, North Carolina 27601 ("**Grantee**") to **PAYFACTORS GROUP, LLC**, a Delaware limited liability company ("**Grantor**"), with its chief executive office at 2 Adams Place, Quincy, Massachusetts 02169.

WHEREAS, pursuant to that certain Security Agreement (Trademarks) dated as of July 21, 2020, made by Grantor in favor of Grantee (the "**Security Agreement**"), a security interest was granted by the Grantor to Grantee in certain Collateral (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on July 22, 2020 at Reel 7005 and Frame 0023; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:


1. **Definitions.** The term "Collateral," as used herein, shall have the meaning set forth in the Security Agreement and shall include all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the trademarks listed on Schedule A hereto.

2. **Release of Security Interest.** Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Collateral and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Collateral.
