**TERMINATION AND RELEASE OF A SECURITY  
INTEREST IN TRADEMARKS**

March 25, 2021

THIS TERMINATION AND RELEASE OF A SECURITY INTEREST IN TRADEMARKS (this “Release”) is made as of March 25, 2020 by ARES CAPITAL CORPORATION, in its capacity as collateral agent under the Credit Agreement (as defined below) (the “Collateral Agent”), in favor of AIRE SERV LLC a Texas limited liability company, DWYER FRANCHISING LLC, a Delaware limited liability company, THE DWYER GROUP, INC., a Delaware corporation, FIVE STAR PAINTING, LLC, a Delaware limited liability company, FOR FRANCHISING, LLC, an Ohio limited liability company, GLASS OPERATING LLC, a Delaware limited liability company, HANDLED.COM LLC, a Delaware limited liability company, HARMON AUTOGLASS INTELLECTUAL PROPERTY LLC, a Delaware limited liability company, MOLLY MAID, LLC, a Michigan limited liability company, MR. APPLIANCE LLC, a Texas limited liability company, MR. ELECTRIC LLC, a Texas limited liability company, MR. HANDYMAN INTERNATIONAL, L.L.C., a Michigan limited liability company, MR. ROOTER LLC, a Texas limited liability company, PROPERTY MANAGEMENT BUSINESS SOLUTIONS, LLC, a Utah limited liability company, PROTRADENET, LLC, a Delaware limited liability company, RAINBOW INTERNATIONAL LLC, a Texas limited liability company, SERVICE BRANDS INTERNATIONAL, L.L.C., a Michigan limited liability company, SYNERGISTIC INTERNATIONAL LLC, a Texas limited liability company, THE DWYER GROUP LLC, a Delaware limited liability company, and THE GROUNDS GUYS LLC, a Texas limited liability company (each a “Grantor” and collectively, the “Grantors”).

WHEREAS, reference is made to the Credit Agreement, dated as of May 31, 2018 (as amended by that certain First Amendment and Waiver to Credit Agreement, dated as of August 10, 2018, that certain Second Amendment to Credit Agreement, dated as of August 24, 2018, that certain Third Amendment to Credit Agreement, dated as of August 14, 2020, and as further amended, restated, extended, supplemented, waived or otherwise modified in writing from time to time, the “Credit Agreement”), by and among TDG INTERMEDIATE, LLC, NEIGHBORLY COMPANY (f/k/a TDG GROUP HOLDING COMPANY), the lenders from time to time party thereto, the Collateral Agent and the other parties party thereto;

WHEREAS, in connection with the Credit Agreement, the Grantors executed and delivered that certain Security Agreement, dated as of May 31, 2018 (as amended, restated, extended, supplemented, waived or otherwise modified in writing from time to time, the “Guaranty and Security Agreement”), pursuant to which the Grantors executed and delivered that certain Trademark Security Agreement, dated as of May 31, 2018, including Schedule I thereto, which was recorded with the United States Patent and Trademark Office at Reel 6340, Frame 0023, on May 31, 2018 (as amended, restated, extended, supplemented, waived or otherwise modified in writing from time to time, the “Trademark Security”

Agreement” and together with the Guaranty and Security Agreement, the “Security Agreements”);

WHEREAS, pursuant to the Security Agreements, the Grantors granted to the Collateral Agent for the benefit of the Secured Parties, a Lien on and security interest in, all of its right, title and interest in, to and under the Trademark Collateral (including, without limitation, the Trademarks referred to on Schedule A hereto) to secure the prompt and complete payment and performance when due of the Secured Obligations; and

WHEREAS, pursuant to that certain Payoff Letter, dated as of March 25, 2021, the Collateral Agent acknowledged the full payment and performance of the Secured Obligations of the Grantors, and accordingly each Grantor has requested, and the Collateral Agent has agreed to provide, a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its security interest in the Trademark Collateral (including, without limitation, the Trademarks referred to on Schedule A hereto).

NOW, THEREFORE, in consideration of the foregoing and in exchange for good and valuable consideration, the Collateral Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.
2. Release of Security Interest; Further Assurances. The Collateral Agent, without any representation and warranty by or any recourse to the Collateral Agent, hereby (i) fully terminates, releases, relinquishes and discharges all of its Lien on and security interest in the Trademark Collateral (including, without limitation, the Trademarks referred to on Schedule A hereto), (ii) transfers and assigns to each Grantor any and all right, title and interest that the Collateral Agent may have in, to and under the Trademark Collateral (including, without limitation, the Trademarks referred to on Schedule A hereto), (iii) agrees that it shall execute all other documents and do all other acts necessary or desirable to relinquish its security interests in the Trademark Collateral (including, without limitation, the Trademarks referred to on Schedule A hereto) and effect the release of such rights to the Grantors and (iv) authorizes and requests that the United States Patent and Trademark Office note and record the release hereby given and any other filings necessary to evidence the release and termination of the Collateral Agent’s rights under each of the Credit Agreement and the Security Agreements with respect to the Trademark Collateral (including, without limitation, the Trademarks referred to on Schedule A hereto).
3. Electronic Delivery. Delivery of an executed signature page of this Release by electronic image scan transmission shall be effective as delivery of a manually executed counterpart hereof.
4. Governing Law. This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
