

These Articles of Entity Conversion (the "Articles") are effective as of May 31, 2018, and are adopted by United Advertising Publications, Inc., a Washington corporation (the "Corporation") pursuant to Section 23B.09.040 of the Revised Code of Washington ("RCW").

The Corporation desires to effect a reorganization in which the Corporation shall be converted (the "Conversion") to ForRent, LLC, a Delaware limited liability company (the "Converted Entity").

Pursuant to Section 23B.09.040:


1. Upon the effectiveness of the Conversion, the Corporation will convert into the Converted Entity;
