RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this “*Release*”) is made and effective as of April 13, 2021, by Ally Commercial Finance LLC, in its capacity as successor-in-interest to GMAC Commercial Finance LLC, as administrative agent (“*Administrative Agent*”) in favor of Old World Industries, LLC, an Illinois limited liability company (“*Grantor*”).

RECITALS

WHEREAS, Grantor and Administrative Agent executed that certain Trademark Security Agreement dated September 30, 2005, and recorded with the United States Patent and Trademark Office (“*USPTO*”) on November 16, 2005 at Reel/Frame No. 3195/0689 (“*Trademark Security Agreement*”) pursuant to which Grantor granted to Administrative Agent a security interest in the Trademark Collateral (as defined in the Trademark Security Agreement) including Grantor’s right, title and interest in the trademarks listed on Schedule A attached hereto (the “*Scheduled Trademarks*”);

WHEREAS, the obligations pursuant to the security interest have been satisfied and Administrative Agent no longer claims an interest in the Scheduled Trademarks.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Administrative Agent agrees as follows:


Release and Reassignment of Security Agreement

Administrative Agent hereby releases and discharges all liens on and security interests in, and hereby reassigns to Grantor, any and all right, title, and interest to the Scheduled Trademarks.

Administrative Agent further agrees that Grantor and its attorneys shall be authorized to file all necessary documents to effectuate the termination and release by the Administrative Agent of all security interests and liens granted to the Administrative Agent pursuant to the Trademark Security Agreement.
