This **TERMINATION OF SECURITY INTEREST IN TRADEMARKS**, dated as of March 17, 2021, is made by BANK OF AMERICA, N.A., as Administrative Agent (the “**Administrative Agent**”) (as defined in the Credit Agreement dated as of December 31, 2012 (as amended, restated, amended and restated, modified or supplemented from time to time), among ACADIA HEALTHCARE COMPANY, INC., a Delaware corporation, the Guarantors from time to time party thereto, the Lenders party thereto from time to time, BANK OF AMERICA, N.A., as the Administrative Agent, and the other agents and arrangers party thereto), in favor of Sonora Behavioral Health Hospital, LLC; TK Behavioral, LLC; Youth and Family Centered Services, Inc.; Acadia Healthcare Company, Inc.; Acadia Merger Sub, LLC; Aspen Education Group, Inc.; CRC Health Corporation; Sierra Tucson, Inc.; Belmont Behavioral Hospital, LLC and Discovery House-Group, LLC (the “**Grantors**”).
