Pursuant to Section 251 of the Delaware General Corporation Law (the “DGCL”) and Section 18-209 of the Delaware Limited Liability Company Act (the “DLLCA”), the undersigned certifies as follows:

**FIRST:** The name, state of domicile, jurisdiction of formation or organization and type of entity of each of the constituent entities are as follows: (i) FIS Energy Systems Inc., a Delaware corporation, and (ii) FIS Capital Markets US LLC, a Delaware limited liability company.

**SECOND:** An Agreement and Plan of Merger (the “Merger Agreement”) has been approved, adopted, certified, executed and acknowledged by each of the constituent entities in accordance with the requirements of Section 251(c) of the DGCL and Section 18-209 of the DLLCA.

**THIRD:** FIS Capital Markets US LLC shall be the surviving limited liability company after the Merger (the “Surviving Company”). The name of the surviving limited liability company shall be FIS Capital Markets US LLC.

**FOURTH:** The limited liability company agreement of FIS Capital Markets US LLC will be the limited liability company agreement of the surviving limited liability company, until such time as it may be amended, modified or otherwise changed in accordance with applicable law.

**FIFTH:** The Merger will become effective on June 29, 2020.

**SIXTH:** The executed Merger Agreement is on file at the principal place of business and office of the Surviving Company, the address of which is 601 Riverside Ave., Jacksonville, FL 32204.

**SEVENTH:** A copy of the Merger Agreement will be furnished by the Surviving Company, on request and without cost, to any stockholder or member of the constituent entities to the Merger.
