Pursuant to Section 18-209 of the Delaware Limited Liability Company Act (the "DLLCA"), the undersigned certifies as follows:

FIRST: The name, state of domicile, jurisdiction of formation or organization and type of entity of each of the constituent limited liability companies are as follows: (i) FIS Shareholder Systems LLC, a Delaware limited liability company, and (ii) FIS Capital Markets US LLC, a Delaware limited liability company.
