## RELEASE OF TRADEMARK SECURITY AGREEMENT

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT ("Release"), dated as of April 22, 2021, is made by **CITIZENS BANK, N.A.** ("Secured Party"), and is as follows:

WHEREAS, **VELOCITY, A MANAGED SERVICES COMPANY, INC.**, a Delaware corporation ("Velocity") formerly known as Velocity The Greatest Phone Company Ever, Inc., **GLOBAL GATEWAY EXCHANGE HOLDINGS, LLC**, an Ohio limited liability company ("GGEH"), and **GLOBAL GATEWAY EXCHANGE, LLC**, an Ohio limited liability company ("GGE" and, together with Velocity and GGEH, each a "Debtor" and, collectively, "Debtors"), and Secured Party are parties to that certain Trademark Security Agreement, dated as of October 13, 2020, which was recorded with the United States Patent and Trademark Office on October 21, 2020 in its records at Reel 007081, Frame 0589 (the "Agreement"); capitalized terms used but not defined herein will have the meaning given to them in the Agreement;
