## AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT

This AMENDED AND RESTATED TRADEMARK SECURITY AGREEMENT, dated as of April 26, 2021 (this "Trademark Security Agreement"), by and among BOYNE USA, INC., a Michigan corporation (the "Borrower"), certain Subsidiaries of the Borrower as identified on the signature pages hereto (such Subsidiaries, collectively with the Borrower, the "Grantors") and WELLS FARGO BANK, NATIONAL ASSOCIATION ("Wells Fargo Bank"), as Administrative Agent (as defined below) for the benefit of the Secured Parties.

Reference is made to (a) the Amended and Restated Credit Agreement dated of even date herewith (as amended, restated, supplemented or otherwise modified from time to time, the "Credit Agreement"), by and among the Borrower, the Lenders and Issuing Lenders from time to time party thereto (collectively, the "Lenders") and Wells Fargo Bank, as administrative agent for the Lenders (the "Administrative Agent"), which Credit Agreement amends, restates, supersedes, and replaces in its entirety the Credit Agreement dated as of May 7, 2018, as amended, supplemented or otherwise modified from time to time up to the First Restatement Effective Date, by and between the Borrower, the lenders party thereto, and Wells Fargo Bank, National Association, in its separate capacities as administrative agent and as letter of credit issuer and swingline lender, and (b) the Amended and Restated Collateral Agreement dated of even date herewith (as amended, restated, supplemented or otherwise modified from time to time, the "Collateral Agreement"), by and among the Borrower, the other Grantors from time to time party thereto and Wells Fargo Bank, as Administrative Agent for the benefit of the Secured Parties, which Collateral Agreement amends, restates, supersedes and replaces in its entirety that First Lien Collateral Agreement dated May 7, 2018, as amended, supplemented or otherwise modified up to the First Restatement Effective Date, executed by the Grantors party thereto in favor of Administrative Agent for the benefit of the Secured Parties. The Lenders and the Issuing Lenders have agreed to maintain and extend credit to the Borrower subject to the terms and conditions set forth in the Credit Agreement. The obligations of the Lenders and the Issuing Lenders to maintain and extend such credit are conditioned upon, among other things, the execution and delivery of this Trademark Security Agreement, which amends and restates the First Lien Trademark Security Agreement dated May 7, 2018, as amended, supplemented or otherwise modified up to the First Restatement Effective Date, by and among the Grantors party thereto and Wells Fargo Bank, as Administrative Agent. The Grantors party hereto (other than the Borrower) are Subsidiaries of the Borrower, will derive substantial benefits from the extension of credit to the Borrower pursuant to the Credit Agreement and are willing to execute and deliver this Trademark Security Agreement in order to induce the Lenders and the Issuing Lenders to extend such credit. Accordingly, the parties hereto agree as follows:

SECTION 1. Defined Terms. Each capitalized term used but not otherwise defined herein shall have the meaning specified in the Credit Agreement or the Collateral Agreement, as applicable. The rules of construction specified in Section 1.2 (except Section 1.2(g)) of the Credit Agreement also apply to this Trademark Security Agreement, mutatis mutandis.

SECTION 2. Grant of Security Interest in Trademark Collateral. As security for the payment and performance in full of the Secured Obligations, each Grantor pursuant to the Collateral Agreement did, and hereby does, grant to the Administrative Agent, its successors and assigns, for the benefit of the Secured Parties, a security interest in all of such Grantor's right, title and interest in the following assets now owned or at any time hereafter acquired by such Grantor or in which such Grantor now has or at any time hereafter may acquire any right, title or interest (the "Trademark Collateral"):

(a) (i) all trademarks, trade names, corporate names, company names, business names, fictitious business names, internet domain names, trade styles, service marks, logos, other business identifiers, whether registered or unregistered, designs and general intangibles of like nature, all registrations and recordings thereof, and all applications in connection therewith (other than each application to register any trademark or service mark prior to the filing under Applicable Law of a verified statement of use for such trademark or service mark) anywhere in the world, including those listed in Schedule I, (ii) all extensions, divisionals and renewals of any of the foregoing, (iii) all income, royalties, damages and payments now or hereafter due and/or payable under any of the foregoing or with respect to any of the foregoing, including damages or payments for past, present or future infringements of any of the foregoing, (iv) the right to sue for past, present or future infringements of any of the foregoing and (v) all rights corresponding to any of the foregoing (including the goodwill and all other assets, rights and interests that uniquely reflect or embody such goodwill) throughout the world;

(b) all Trademark Licenses under which any Grantor is a licensee, including those referred to in Schedule I; and

(c) all Proceeds with respect to any of the foregoing.


SECTION 3. Collateral Agreement. The security interests granted to the Administrative Agent herein are granted in furtherance, and not in limitation of, the security interests granted to the Administrative Agent pursuant to the Collateral Agreement. Each Grantor hereby acknowledges and affirms that the rights and remedies of the Administrative Agent with respect to the Trademark Collateral are more fully set forth in the Collateral Agreement, the terms and provisions of which are hereby incorporated herein by reference as if fully set forth herein. In the event of any conflict between the terms of this Trademark Security Agreement and the Collateral Agreement, the terms of the Collateral Agreement shall govern.

SECTION 4. Counterparts. This Trademark Security Agreement may be executed in any number of counterparts (and by different parties hereto in separate counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract. Delivery of an executed counterpart of a signature page to this Trademark Security Agreement by facsimile or in electronic (i.e., "pdf" or "tif") form shall be effective as delivery of a manually executed counterpart of this Trademark Security Agreement.
