**TERMINATION AND RELEASE OF SECURITY INTEREST  
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of April 30, 2021 (“Release”), is made by Bank of America, N.A. (“Secured Party”) in favor of Commercial Vehicle Group, Inc, a Delaware corporation, CVG National Seating Company, LLC, a Delaware limited liability company, CVG AR LLC, a Delaware limited liability company, CVG Monona, LLC, an Delaware limited liability company, CVG Monona Wire, LLC, an Iowa limited liability company, Trim Systems, Inc., a Delaware corporation, Trim Systems Operating Corp., a Delaware corporation, Cabarrus Plastics, Inc., a North Carolina corporation, CVG CVS HOLDINGS, LLC, a Delaware limited liability company, CVG Sprague Devices, LLC, a Delaware limited liability company, Mayflower Vehicle Systems, LLC, a Delaware limited liability company, CVG Management Corporation, a Delaware corporation, CVG Logistics, LLC, a Delaware limited liability company, and CVG Alabama, LLC, a Delaware limited liability company (each a “Grantor”, and collectively, the “Grantors”).

**WHEREAS**, pursuant to that certain Third Amended Loan and Security Agreement dated as of April 12, 2017 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Security Agreement”) by and among the Grantors, Secured Party, and others party thereto, the Trademark Security Agreement dated as of January 7, 2009 by and among the Grantors thereto and Secured Party (“Trademark Security Agreement”), the First Amendment to the Trademark Security Agreement dated as of November 15, 2013 (“First Amendment”), and the Second Amendment to the Trademark Security Agreement dated as of April 12, 2017 (“Second Amendment”), Grantors granted to the Secured Party, for the ratable benefit of the Lenders and other holders of the Secured Obligations (collectively, the “Secured Parties”), a security interest in, and a Lien upon, all right, title and interest of Grantors in and to the Collateral (as defined in the Trademark Security Agreement), including the foregoing listed on Schedule A attached hereto; and

**WHEREAS**, the Trademark Security Agreement was recorded at the United States Patent and Trademark Office (“USPTO”) on January 14, 2009 at Reel 3919 Frame 0030, the First Amendment was recorded at the USPTO on January 10, 2014 at Reel 5190 Frame 0557, and the Second Amendment was recorded at the USPTO on August 24, 2017 at Reel 6137 Frame 0853.

**NOW THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Secured Party, on behalf of the Secured Parties, and Grantor agree as follows:

**SECTION 1. Defined Terms.** All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Security Agreement, Trademark Security Agreement, First Amendment, or Second Amendment.

**SECTION 2. Termination and Release.** Secured Party, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in, and a Lien upon, all right, title and interest of Grantors in and to the Collateral (as defined in the Trademark Security Agreement), including the foregoing listed on Schedule A attached hereto, granted pursuant to the Security Agreement, Trademark Security Agreement, First Amendment, or Second Amendment; and

(b) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

**SECTION 3. Choice of Law.** This Release shall be governed by and construed in accordance with the laws of the State of New York.

**SECTION 4. Acknowledgement.** The release of security interest granted herein expressly does not include a release of the security interest granted pursuant to the Security and Pledge Agreement dated as of April 30, 2021 (as amended, restated, amended and restated, extended, supplemented or otherwise modified from time to time) by and among the one or more of the Grantors, Bank of America, N.A., in its capacity as Administrative Agent thereto, and others party thereto.


