**TERMINATION AND RELEASE
OF TRADEMARK SECURITY AGREEMENT**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY AGREEMENT (this "Termination"), is dated as of April 1, 2021, and made by **PNC BANK, NATIONAL ASSOCIATION**, in its capacity as agent for the Lenders ("Agent"), to **ZOOMDATA, INC.**, a Delaware corporation ("Grantor").

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of June 3, 2019, made by Grantor in favor of Agent (the "Security Agreement"), a security interest was granted by the Grantor to Agent in the Trademark Collateral, including the those listed on Exhibit A attached hereto;

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on June 4, 2019 at Reel/Frame 049357/0079 and Reel/Frame 6660/0736;

WHEREAS, Agent now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Trademark Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Agent hereby states as follows:

1. Definitions. All capitalized terms as used herein, but not otherwise defined herein shall have the meanings ascribed or referenced to them under the Security Agreement.

2. Release of Security Interest. Agent hereby terminates and cancels the Security Agreement and terminates, cancels, releases and discharges all of its security interest in the Trademark Collateral and reassigns to the Grantor all right, title and interest of Agent in the Trademark Collateral (if any). The Agent agrees, or authorizes the Grantor, to make filings with the United States Patent and Trademark Office and take further actions, as reasonably requested by the Grantor to evidence the release and termination of the Agent's security interests in the Trademark Collateral.
