If Assignor possesses any such rights that cannot be assigned to Assignee, Assignor waives the enforcement of such rights, and if Assignor has any rights that cannot be assigned or waived, Assignor hereby grants to Assignee an exclusive, irrevocable, perpetual, worldwide, fully paid license, with right to sublicense, to such rights.
3. **Recordation and Further Actions.** Assignor authorizes the Commissioner for Trademarks and any other governmental officials to record and register this assignment upon request by Assignee. Assignor will take such steps and actions, including the execution of any documents, files, registrations, or other similar items, to ensure that the Assigned Marks are properly assigned to Assignee, or any assignee or successor thereto.
4. **Successors and Assigns.** This assignment shall be binding upon and shall inure to the benefit of the Assignee and its successors and assigns.
5. **Governing Law.** This assignment shall be governed by the laws of the state of Ohio, both as to interpretation and performance.
