**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN INTELLECTUAL PROPERTY**

TERMINATION AND RELEASE dated as of April 30, 2021, from U.S. BANK NATIONAL ASSOCIATION, as notes collateral agent (in such capacity, together with its successors and assigns in such capacities, the “Collateral Agent”), on behalf of itself and the Notes Secured Parties, to GAMESTOP, INC., a Minnesota corporation, GAMESTOP CORP., a Delaware corporation, SOCOM LLC, a Delaware limited liability company, SUNRISE PUBLICATIONS, INC., a Minnesota corporation, ELBO INC., a Delaware corporation, EB INTERNATIONAL HOLDINGS, INC., a Delaware corporation, GAMESTOP TEXAS LTD., a Delaware corporation, MARKETING CONTROL SERVICES, INC., a Virginia corporation, GS MOBILE, INC., a Delaware corporation, GEEKNET, INC., a Delaware corporation, and GME ENTERTAINMENT LLC, a Delaware limited liability company (collectively the “Grantors” and each individually, a “Grantor”).

WITNESSETH:

WHEREAS, pursuant to the Pledge and Security Agreement, dated as of July 6, 2020, in favor of the Collateral Agent (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), each Grantor pledged, assigned and granted a continuing security interest (the “Security Interest”) to the Collateral Agent in all of such Grantor’s right, title and interest to and under intellectual property of every kind and nature then owned or thereafter acquired by such Grantor, including Patents, Copyrights and Trademarks, and all products, proceeds, substitutions, and accessions of or to any of the foregoing;

WHEREAS, pursuant to that certain Patent, Trademark and Copyright Security Agreement entered into as of July 6, 2020, in favor of the Collateral Agent and executed by each Grantor (the “IP Security Agreement”), each Grantor, by reference to the Security Agreement, pledged, mortgaged, transferred and granted to the Collateral Agent the Security Interest in all of such Grantor’s right, title and interest in and to all IP Collateral (as defined in the IP Security Agreement), including, without limitation, the registrations and applications set forth on Schedule I hereto (collectively, the “Collateral”);

WHEREAS, the IP Security Agreement was recorded in the United States Patent and Trademark Office on July 20, 2020 at Reel/Frame 7002/0596 and received at the United States Copyright Office on July 28, 2020;

WHEREAS, the Collateral Agent now desires to terminate and release the entirety of its Security Interest in the Collateral;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination and Release, the Collateral Agent hereby states as follows:

1. Definitions. Capitalized terms used in this Termination and Release and not otherwise defined herein have the meanings specified in the IP Security Agreement or Security Agreement, as applicable.

2. Release of Security Interest. The Collateral Agent hereby terminates, releases and discharges fully, without recourse, representation or warranty, the Security Interest in the Collateral, including without limitation the Collateral listed on Schedule I attached hereto, and any right, title or interest of the Collateral Agent in such Collateral shall hereby cease and become void.

3. Further Assurances. The Collateral Agent hereby agrees to duly execute, acknowledge, procure and deliver any further documents and to do such other acts as may be reasonably necessary to effect the release of the Security Interest contemplated hereby, which shall be at the Grantors' sole cost and expense.

4. Governing Law. This Termination and Release shall be governed exclusively under the laws of the State of New York, without regard to conflicts of law or choice of law provisions.

5. Electronic Signature. This Termination and Release may be executed in any number of counterparts, each of which, when so executed, shall be deemed to be an original and all of which, taken together, shall constitute one and the same Termination and Release. Delivery of an executed counterpart of a signature page to this Termination and Release by telecopier or other electronic communication shall be as effective as delivery of an original executed counterpart of this Termination and Release. The words "execution," "signed," "signature," "delivery," and words of like import in this Termination and Release shall be deemed to include electronic signatures or electronic records, each of which shall be of the same legal effect, validity or enforceability as a manually executed signature, physical delivery thereof or the use of a paper-based recordkeeping system, as the case may be, to the extent and as provided for in any applicable law, including the Federal Electronic Signatures in Global and National Commerce Act, the New York State Electronic Signatures and Records Act, or any other similar state laws based on the Uniform Electronic Transactions Act.


