**RELEASE OF TRADEMARK SECURITY AGREEMENT**

THIS RELEASE OF TRADEMARK SECURITY AGREEMENT, dated as of June 2, 2021 (this “**Release**”), is made by ANKURA TRUST COMPANY, LLC, as Collateral Agent for the Secured Parties (in such capacity and together with its successors and permitted assigns, the “**Agent**”) under that certain Trademark Security Agreement, dated as of May 8, 2020 (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “**Trademark Security Agreement**”) by NFP CORP., a Delaware corporation, the “**Grantor**”), in favor of the Agent. Unless otherwise defined herein, terms defined in the Trademark Security Agreement and used herein have the meaning given to them in the Trademark Security Agreement.

WHEREAS, pursuant to the Trademark Security Agreement which was recorded in the records of the United States Patent and Trademark Office on May 8, 2020 at reel 6933, frame 0560, the Grantor granted to the Agent a lien on and security interest in all of the Grantor’s right, title and interest in or to any and all of the Collateral (as defined therein), including such Collateral set forth on the attached Schedule I and

WHEREAS, the Grantor has requested and the Agent has agreed to provide a document suitable for recording in the United States Patent and Trademark Office evidencing and effecting the release, relinquishment and discharge of its lien on and security interest in the Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent does hereby, in each case, absolutely, unconditionally, irrevocably and forever, without representation or warranty (express or implied): (a) terminate the Trademark Security Agreement, (b) release, discharge, cancel and terminate the liens and security interest created under the Trademark Security Agreement in the Collateral, (c) release, discharge, cancel and terminate its security interest in the Collateral, and (d) release and discharge any and all rights, title and interest it has in and the security interest granted to the Agent in the Collateral, including any and all goodwill relating to the same. The Agent, on behalf of itself and the Secured Parties, authorizes and requests that the Commissioner of Trademarks and any other applicable government officer record this Release.

THIS RELEASE SHALL BE GOVERNED BY, AND CONSTRUED AND INTERPRETED IN ACCORDANCE WITH, THE LAWS OF THE STATE OF NEW YORK.
