RELEASE OF SECURITY INTERESTS IN TRADEMARKS

THIS RELEASE OF SECURITY INTERESTS IN TRADEMARKS (this “Release”) is made as of June 3, 2021 (“Effective Date”) by Goldman Sachs Bank USA (the “Administrative Agent”), in favor of Camp Coast to Coast, LLC, a Delaware limited liability company, Camping World, Inc., a Kentucky corporation, CWI, Inc., a Kentucky corporation, Good Sam Enterprises, LLC, a Delaware limited liability company, TL Enterprises, LLC, a Delaware limited liability company, Active Sports, Inc., a Minnesota corporation, W82, LLC, a Minnesota limited liability company and Uncle Dan’s, Ltd., an Illinois corporation (collectively, the “Grantors” and each, a “Grantor”). Capitalized terms not defined herein shall have the meanings ascribed to such terms in the Collateral Agreement or the Trademark Security Agreements (as defined below), as applicable.

WHEREAS, the Grantors, CWGS Enterprises, LLC (“Holdings”), CWGS Group, LLC (the “Borrower”), the Administrative Agent and the other parties thereto entered into that certain Collateral Agreement dated as of November 8, 2016 (as amended, restated, supplemented or otherwise modified from time to time, the “Collateral Agreement”), which required the parties to enter into the Trademark Security Agreements;

WHEREAS, (i) the Grantors party thereto and the Administrative Agent entered into that certain Trademark Security Agreement, dated as of November 8, 2016, which was recorded with the United States Patent and Trademark Office on November 14, 2016, at Reel 5920, Frame 0643 (the “2016 Trademark Security Agreement”) and (ii) the Grantors party thereto and the Administrative Agent entered into that certain Trademark Security Agreement, dated as of December 11, 2017, which was recorded with the United States Patent and Trademark Office on December 18, 2017 at Reel 6231, Frame 0196 (the “2017 Trademark Security Agreement” and, together with the 2016 Trademark Security Agreement, the “Trademark Security Agreements”), under which each Grantor granted to the Administrative Agent, for the benefit of the Secured Parties, a security interest (the “Security Interests”) in all of such Grantor’s right, title and interest in, to and under the trademarks and trademark applications listed on Schedule I attached hereto, including all Proceeds and products thereof and all rights to sue for past, present and future infringements, misappropriations or violations thereof (collectively, the “Trademark Collateral”).

WHEREAS, pursuant to the payoff letter dated as of June 3, 2021, between the Borrower and the Administrative Agent, the Administrative Agent has agreed to take actions reasonably necessary to release and terminate any and all security interests it may have in the Trademark Collateral pursuant to the Loan Documents, and the Grantors hereby request a specific release of the Security Interests granted and recorded against the Trademark Collateral.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent hereby, on behalf of itself and the Secured Parties, (i) terminates the Trademark Security Agreements, (ii) releases any and all Security Interests or other liens, security interests, right, title and interest the Administrative Agent or any Secured Parties may have in, to or under the Trademark Collateral pursuant to the Trademark Security Agreements and the other Loan Documents, and (iii) re-assigns to the applicable Grantor, any right, title or interest the Administrative Agent or any Secured Parties may have in, to or under the Trademark Collateral, together with the goodwill of

the business symbolized thereby, in each case pursuant to the Trademark Security Agreements and the other Loan Documents.


The execution and/or delivery of this Release and any further documents and the actions associated with the release of the Security Interests and the Trademark Collateral referred to in this Release by the Administrative Agent are made without recourse to or warranty by the Administrative Agent or any Secured Party.

This Release shall be governed by, and construed and interpreted in accordance with, the laws of the State of New York.
