**TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS**

This **TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS**, dated as of June 4, 2021 (“Release”), is made by Bank of America, N.A., as Collateral Agent (“Collateral Agent”) in favor of CoreLogic Solutions, LLC, a California limited liability company (“Grantor”).

WHEREAS, pursuant to that certain Guarantee and Collateral Agreement dated as of March 25, 2014 (as amended, modified, extended or restated from time to time, the “Collateral Agreement”) by and among the Grantor, Collateral Agent, and others party thereto, Grantor granted to the Collateral Agent, for the ratable benefit of the Secured Parties, a security interest in all Trademarks (to the extent are Collateral) owned by Grantor, including the trademark registrations and trademark applications listed on Schedule A attached hereto (collectively, “Trademark Collateral”); and

WHEREAS, pursuant to the Collateral Agreement, Grantor executed and delivered to Collateral Agent, for the benefit of the Secured Parties, the Grant of Security Interest in Trademark Rights recorded at the United States Patent and Trademark Office (“USPTO”) on May 1, 2014 at Reel 5271 Frame 0724 (“Notice”).

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, Collateral Agent, on behalf of the Secured Parties, and Grantor agree as follows:

SECTION 1. Defined Terms. All capitalized terms used herein but not otherwise defined herein have the meanings given to them in the Collateral Agreement or Notice.

SECTION 2. Termination and Release. Collateral Agent, on behalf of the Secured Parties, without representation, warranty, or recourse, hereby:

(a) terminates, cancels, discharges, and releases the security interest in the Trademark Collateral granted pursuant to the Collateral Agreement or Notice;

(b) terminates and cancels the Notice; and

(c) authorizes the recordation of this Release with the USPTO at Grantor’s expense.

SECTION 3. CHOICE OF LAW. THIS RELEASE SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAWS OF THE STATE OF NEW YORK.

IN WITNESS WHEREOF, the Collateral Agent, on behalf of the Secured Parties, has caused this Termination and Release of Security Interest in Trademarks to be duly executed as of the date first set forth above.
