**ASSIGNMENT OF GRANTS OF SECURITY INTERESTS IN PATENTS,

Pursuant to the Security Agreement, Alex and Ani, LLC, as a Grantor (as defined in the Security Agreement) executed and delivered to the Administrative Agent, for the ratable benefit of the Secured Parties (as defined in the Security Agreement), that certain Notice of Grant of Security Interest in Trademarks dated September 13, 2019 (the "**2019 Notice of Grant of Trademarks**"), identifying certain trademarks and trademark applications shown on Schedule 1 attached thereto that became subject to the provisions of the Security Agreement, which 2019 Notice of Grant of Trademarks was recorded in the United States Patent and Trademark Office on November 8, 2019 in reel 6792 and frame 0670.

Pursuant to the Security Agreement, Alex and Ani, LLC, as a Grantor (as defined in the Security Agreement) executed and delivered to the Administrative Agent, for the ratable benefit of the Secured Parties (as defined in the Security Agreement), that certain Notice of Grant of Security Interest in Patents dated as of January 29, 2016 (the "**2016 Notice of Grant of Patents**"), identifying certain patents and patent applications shown on Schedule 1 attached thereto that became subject to the provisions of the Security Agreement, which 2016 Notice of Grant of Patents was recorded in the United States Patent and Trademark Office on February 4, 2016 in reel 037668 and frame 0024.

Pursuant to the Security Agreement, Alex and Ani, LLC, as a Grantor (as defined in the Security Agreement) executed and delivered to the Administrative Agent, for the ratable benefit of the Secured Parties (as defined in the Security Agreement), that certain Notice of Grant of Security Interest in Patents dated September 13, 2019 (the "**2019 Notice of Grant of Patents**"), identifying certain patents and patent applications shown on Schedule 1 attached thereto that became subject to the provisions of the Security Agreement, which 2019 Notice of Grant of Patents was recorded in the United States Patent and Trademark Office on November 13, 2019 in reel 051005 and frame 0077.

Pursuant to the Security Agreement, Alex and Ani, LLC, as a Grantor (as defined in the Security Agreement) executed and delivered to the Administrative Agent, for the ratable benefit of the Secured

Parties (as defined in the Security Agreement), that certain Notice of Grant of Security Interest in Copyrights dated September 13, 2019 (the “**Notice of Grant of Copyrights**”), identifying certain copyrights and copyright applications shown on Schedule 1 attached thereto that became subject to the provisions of the Security Agreement, which Notice of Grant of Copyrights was received for recording in the United States Copyright Office on November 12, 2019.¹

This Assignment is being executed and delivered pursuant to that certain Loan Sale and Assignment Agreement dated as of May 26, 2021 by and between Assignor and LC A&A Holdings, Inc. (the “**Loan Sale Agreement**”). All capitalized terms used but not defined herein shall have the meanings ascribed to them in the Loan Sale Agreement.

For and in consideration of Ten Dollars (\$10.00) and other good and valuable consideration, the adequacy and receipt of which is hereby acknowledged, Assignor does hereby, through its duly appointed and authorized officers and/or representatives, sell, transfer, assign, deliver, set over and convey to Assignee, Assignor’s rights and interests, as Administrative Agent for the Secured Parties (as defined in the Security Agreement) in the Security Agreement and each of the 2016 Notice of Grant of Trademarks, the 2019 Notice of Grant of Trademarks, the 2016 Notice of Grant of Patents, the 2019 Notice of Grant of Patents and the Notice of Grant of Copyrights (collectively, the “**Assigned Intellectual Property Documents**”).

TO HAVE AND TO HOLD unto Assignee, forever, the Assigned Intellectual Property Documents, together with all and singular the rights, titles, interests, privileges, liens, entitlements, claims, demands and equities as to which the Assignor hereunder possesses or to which the Assignor is otherwise entitled in connection therewith, except with respect to Assignor’s continuing rights under the Security Agreement.

Assignee hereby assumes all obligations of Assignor under the Assigned Intellectual Property Documents, accruing from and after the date hereof.

This Assignment is made without recourse and without any representation or warranty of any kind whatsoever, express or implied, or by operation of law except as may be set forth in the Loan Sale Agreement. The Assigned Intellectual Property Documents are being assigned by Assignor, as Administrative Agent for the Secured Parties (as defined in the Security Agreement), and assumed by Assignee “AS-IS”. This Assignment may be executed in a number of multiple identical counterparts which, when taken together, shall constitute collectively one Assignment, but in making proof of this Assignment it shall not be necessary to produce or account for more than one such counterpart executed by the party to be charged.
