**AMENDED AND RESTATED  
TRADEMARK SECURITY AGREEMENT**

This Amended and Restated Trademark Security Agreement (this "Agreement") dated as of June 4, 2021, is made by and among Networks Associates, Inc., a Delaware corporation ("Holdings"), Network Services Company, a Delaware corporation ("Network Services"), National Paper & Plastics Company, Inc., an Illinois corporation ("National Paper") and collectively with Holdings, Network Services, the "Grantors" and each a "Grantor") and JPMorgan Chase Bank, N.A., as Lender (the "Lender").

WHEREAS, the Grantors, the other Loan Parties party thereto and the Lender party thereto entered into that certain Credit Agreement dated June 9, 2016 (as amended up to but not including the date hereof, the "Original Credit Agreement");

WHEREAS, the Grantors previously executed and delivered to the Lender that certain Security Agreement dated as of June 9, 2016 executed by the Grantors and the other Loan Parties party thereto (including annexes, exhibits or schedules thereto, as amended through the date hereof, the "Original Security Agreement") in favor of the Lender and that certain Trademark Collateral Agreement dated as of June 9, 2016, between Network Services and the Lender (including all annexes, exhibits or schedules thereto, as amended or supplemented through the date hereof, the "Existing Trademark Security Agreement");

WHEREAS, the Grantors, the other Loan Parties party thereto and the Lender are concurrently entering into that certain Amended and Restated Credit Agreement dated as of the date hereof (as from time to time amended, restated, supplemented or otherwise modified, the "Credit Agreement") and the Grantors, the other Loan Parties party thereto and the Lender are concurrently entering into that certain Amended and Restated Pledge and Security Agreement dated as of the date hereof (as from time to time amended, restated, supplemented or otherwise modified, the "Pledge and Security Agreement");

WHEREAS, as a condition to the Lender entering into the Credit Agreement, and pursuant to the Pledge and Security Agreement, Network Services have agreed to amend and restate the Existing Trademark Security Agreement; and

WHEREAS, capitalized terms used herein but not defined herein shall have the meaning assigned to them in the Credit Agreement or the Pledge and Security Agreement, as applicable.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, each Grantor hereby confirms the grant pursuant to the Pledge and Security Agreement, to the Lender, of a security interest in all of such Grantor's right, title and interest in, to and under the following, whether presently existing or hereafter arising or acquired:

- (i) all Trademarks and all of the goodwill of the business symbolized by each Trademark of such Grantor, including, without limitation, each Trademark listed on Schedule A;

(ii) all income, royalties, and damages hereafter due or payable with respect to any Trademark, including, without limitation, each Trademark listed on Schedule A; and

(iii) all claims by such Grantor against third parties for (a) income, royalties, and damages hereafter due or payable with respect to any Trademark, and (b) past, present or future infringement of any Trademark.

The rights and remedies of the Lender with respect to the security interest described herein are set forth in the Pledge and Security Agreement, all terms and provisions of which are incorporated herein by reference. In the event that any provisions of this Agreement are deemed to conflict with the Pledge and Security Agreement, the provisions of the Pledge and Security Agreement shall govern.

This Agreement may be executed in counterparts (and by different parties hereto on different counterparts), each of which shall constitute an original, but all of which when taken together shall constitute a single contract.

On the Closing Date, this Agreement shall amend and restate the Original Trademark Security Agreement in its entirety, without constituting a novation. The parties hereto acknowledge and agree that the Liens as granted under the Original Trademark Security Agreement and the other Collateral Documents securing and guaranteeing payment of the Secured Obligations (as defined in the Original Credit Agreement) are in all respects continuing and in full force and effect and secure and guarantee the payment of the Secured Obligations (as defined in the Credit Agreement) and are hereby fully ratified and affirmed. Without limitation of the foregoing, each Grantor hereby fully and unconditionally ratifies and reaffirms each other Collateral Document delivered in connection with the Original Credit Agreement and the Original Security Agreement and agrees that each such Collateral Document is continuing in all respects and is in full effect and all collateral granted thereunder shall from and after the date hereof secure all Secured Obligations.




