**TERMINATION AND RELEASE OF  
INTELLECTUAL PROPERTY SECURITY AGREEMENT**

This **TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this “*Termination and Release*”) is granted as of June 10, 2021 by **SILICON VALLEY BANK**, as Administrative Agent (the “*Assignee*”), in favor of **COMPEAT, INC.** (the “*Grantor*”).

**WHEREAS**, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of June 14, 2018 (as amended, restated, supplemented or otherwise modified prior to the date hereof, the “*Grant*”) granting the Assignee a security interest in and lien on certain trademarks and trademark applications (“*Trademarks*”) described therein, which was recorded with the United States Patent and Trademark Office (“*USPTO*”) on June 14, 2018, at Reel 6353, Frame 0111;

**WHEREAS**, the Grantor has requested that Assignee hereby terminate, release and discharge fully its security interests in and liens on all right, title and interest of the Grantor in, to and under all of the Trademarks identified in Schedule I hereto as herein provided; and

**WHEREAS**, the Grantor has requested that the Assignee provide a document suitable for recording with the USPTO to evidence the release of the Assignee’s security interests in and liens on the certain Trademarks as herein provided.

**NOW, THEREFORE**, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignee hereby:


1. terminates the Grant and releases, terminates and discharges all liens and security interests in the Grantor’s right, title and interest in, to and under those certain Trademarks identified in Schedule I hereto, and all goodwill associated therewith; and
2. authorizes and requests that this Termination and Release be recorded at the USPTO.
