**TERMINATION AND RELEASE OF
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of June 22, 2021, by **UBS AG, STAMFORD BRANCH**, a Switzerland Aktiengesellschaft (AG) (“Administrative Agent”) in favor of **DRYNACHAN, LLC**, a Delaware limited liability company with an address at 14121 Parke Long Court, Chantilly, Virginia, 20151, **CENSEO HEALTH, LLC**, a Delaware limited liability company with an address at 4055 Valley View Lane, Suite 400, Dallas, Texas, 75244, and **PRINCIPIUM HEALTH, LLC**, a Delaware limited liability company with an address at 4055 Valley View Lane, Suite 400, Dallas, Texas, 75244 (each, a “Grantor” and collectively, the “Grantors”).

WITNESSETH:

WHEREAS, with reference to the Security Agreement, dated as of December 21, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantors entered into a Trademark Security Agreement dated December 21, 2017 with the Administrative Agent, notice of which was recorded on May 3, 2018 at the United States Patent and Trademark Office at Reel 6325, Frame 0693.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantors granted the Administrative Agent, under the terms of the Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of each such Grantor’s right, title and interest in, to and under its Trademark Collateral, including without limitation its Trademarks listed in Schedule A.

WHEREAS, the Administrative Agent and Principium Health, LLC entered into a Partial Termination and Release of Security Interest in Trademarks dated February 28, 2019, notice of which was recorded on February 28, 2019 at the United States Patent and Trademark Office at Reel 6577, Frame 0827, pursuant to which the Administrative Agent released, terminated and discharged any and all of its interest in Trademark application numbers 87239100 and 87325701.

WHEREAS, the Administrative Agent has agreed to terminate and release its Security Interest in all remaining Trademark Collateral, including the Trademarks listed in Schedule A as herein provided.


NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, and intending to be legally bound, the Administrative Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral, including the Trademarks listed in Schedule A hereto, and assigns, transfers and conveys to Grantors the Security Interest.

This agreement shall be governed by, and construed in accordance with, the law of the State of New York.
