**TERMINATION AND RELEASE OF  
SECURITY INTEREST IN TRADEMARKS**

This Termination and Release of Security Interest in Trademarks (“Release”) is made as of June 22, 2021, by **UBS AG, STAMFORD BRANCH**, a Switzerland Aktiengesellschaft (AG) (“Administrative Agent”) in favor of **TAVHEALTH, LLC**, a Delaware limited liability company with an address at 4055 Valley View Lane, Suite 400, Dallas, Texas 75244 (the “Grantor”).

WITNESSETH:

WHEREAS, with reference to the Security Agreement, dated as of December 21, 2017 (as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), the Grantor entered into a Trademark Security Agreement dated April 19, 2019 with the Administrative Agent.

Capitalized terms used but not otherwise defined herein have the meanings given to them in the Trademark Security Agreement.

WHEREAS, Grantor granted the Administrative Agent, under the terms of the Security Agreement, a continuing security interest (the “Security Interest”) in favor of the Administrative Agent, in and to all of such Grantor’s right, title and interest in, to and under its Trademark Collateral, including without limitation its Trademarks listed in Schedule A.

WHEREAS, the Administrative Agent has agreed to terminate and release its Security Interest in the Trademark Collateral, including the Trademarks listed in Schedule A as herein provided.


NOW, THEREFORE, in consideration of the foregoing and other good and valuable consideration, the receipt and adequacy of which is hereby acknowledged, and intending to be legally bound, the Administrative Agent hereby releases, terminates and discharges any and all of its interest in the Trademark Collateral, including the Trademarks listed in Schedule A hereto, and assigns, transfers and conveys to Grantor the Security Interest.

This agreement shall be governed by, and construed in accordance with, the law of the State of New York.
