## RELEASE OF SECURITY INTERESTS IN TRADEMARKS

This RELEASE OF SECURITY INTERESTS IN TRADEMARKS is executed as of November 9, 2020 by **WELLS FARGO CAPITAL FINANCE, INC.** (f/k/a Wells Fargo Foothill, Inc. ("Wells Fargo"), as administrative agent (in such capacity, together with its successors and permitted assigns, the "Agent"). Any capitalized term not otherwise defined herein shall have the meaning ascribed to it in the Trademark Security Agreement (as defined below).

WHEREAS, each of the entities listed on Schedule I attached hereof (each a "Grantor" and, collectively, the "Grantors"), entered into that certain: (i) Trademark Security Agreement, dated as of March 14, 2006 (as supplemented on October 24, 2008 and as reaffirmed by that Master Reaffirmation Agreement dated as of November 9, 2015, the "2006 Trademark Agreement"); (ii) Supplement to Trademark Security Agreement, dated as of November 9, 2015 (the "2015 Trademark Agreement Supplement") (iii) Supplement to Trademark Security Agreement dated as of June 28, 2016 (the "2016 Trademark Agreement Supplement"); and (iv) Supplement to Trademark Security Agreement dated as of July 14, 2020 (the "2020 Trademark Agreement Supplement"; together with the 2006 Trademark Agreement, 2015 Trademark Agreement, and 2016 Trademark Agreement, each a "Trademark Agreement" and collectively, the "Trademark Agreements") with the Agent.

WHEREAS, pursuant to the Trademark Agreements, each Grantor granted to the Agent, as security for the Obligations, a continuing security interest in all of such Grantor's right, title and interest in and to certain trademarks;

WHEREAS, the security interests in trademarks were recorded in the Trademark Division of the United States Patent and Trademark Office (i) on April 5, 2006, at Reel 003283 and Frame 0223 (supplemented on October 24, 2008, at Reel 003875 and Frame 0981), (ii) on November 18, 2015 at Reel: 005672 and Frame 0277, (iii) on July 6, 2016 at Reel 005829 and Frame 0079; and (iv) on July 17, 2020 at Reel 007001 and Frame 0493; and

WHEREAS, each Grantor has requested that the Agent release the liens and security interests granted to the Agent by such Grantor with respect to the Trademark Collateral, including but not limited to those Trademarks listed on Exhibit A attached hereto.

For good and valuable consideration, receipt of which is hereby acknowledged, the Agent hereby:

- (a) releases the liens and security interests granted by each Grantor to the Agent pursuant to any security agreement (including but not limited to the Trademark Agreement) in and to the Trademark Collateral; and
- (b) to the extent the Agent shall be deemed to have any right, title or interest in the Trademark Collateral, retransfers and reassigns, without representation, warranty or recourse, to each Grantor all of such right, title and interest solely with respect to the Trademark Collateral.

This Release of Security Interests in Trademarks shall be governed by the laws of the State of New York.
