**TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST**

THIS TERMINATION AND RELEASE OF TRADEMARK SECURITY INTEREST (this "Release"), dated as of June 23, 2021 is entered into by and among **UW HOLDINGS, LLC**, a Delaware limited liability company (the "Parent"), **UW INTERCO, LLC**, a Delaware limited liability company ("Holdings"), **UW INTERCO II, LLC**, a Delaware limited liability company ("Holdings II"), **UW INTERCO CORP.**, a Delaware corporation ("UW Corp"), **UW INTERNATIONAL SALES, INC.**, a Delaware corporation ("UW Sales"), **UNIVERSAL WOODS, LLC**, a Kentucky limited liability company (formerly Universal Woods Incorporated) ("Universal Woods OpCo"), **UNIVERSAL WOODS INTERNATIONAL, LLC**, a Kentucky limited liability company ("UW International"), **CORNERSTONE SPECIALTY WOOD PRODUCTS, LLC**, a Kentucky limited liability company ("Cornerstone"), and **R & D COATINGS, LLC**, a Delaware limited liability company ("R & D Coatings"; together with the Parent, Holdings, Holdings II, UW Corp, UW Sales, Universal Woods OpCo, UW International and Cornerstone, each a "Pledgor" and, collectively, the "Pledgors"), in favor of **PNC BANK, NATIONAL ASSOCIATION**, as administrative agent (in such capacity, the "Administrative Agent").

**WITNESSETH:**

WHEREAS, the Pledgors executed and delivered to the Administrative Agent (i) that certain Patent, Trademark and Copyright Security Agreement, dated as of March 15, 2019, by and between certain of the Pledgors and the Administrative Agent and (ii) that certain Patent, Trademark and Copyright Security Agreement, dated as of January 8, 2020, by and between certain of the Pledgors and the Administrative Agent (collectively, the "Security Agreements");

WHEREAS, pursuant to the Security Agreements, the Pledgors granted to the Administrative Agent, for the benefit of the Secured Parties (as defined in the Security Agreement), a security in and to all of the right, title and interest of Pledgors in, to and under the Trademark Collateral (as defined below);

WHEREAS, the Security Agreements were recorded with the United States Patent and Trademark Office at Reel/Frame 6593/0208 on March 18, 2019 and Reel/Frame 6881/0545 on March 4, 2020;

WHEREAS, the Pledgors have requested that the Administrative Agent enter into this Release in order to effectuate, evidence and record the release and termination by the Administrative Agent of the security interest and any other right, title or interest the Administrative Agent may have in the Trademark Collateral pursuant to the Security Agreements.

NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, intending to be legally bound hereby, and upon the terms set forth in this Release, the Administrative Agent hereby agrees as follows:

**1. Release of Security Interest.** The Administrative Agent hereby terminates, releases and discharges any and all right, title, security interests, interest of every kind and

nature, or other rights that the Administrative Agent has in any of the following (collectively, the "Trademark Collateral"):

a. any and all trademarks set forth on Exhibit A hereto, together with the goodwill connected with the use thereof and symbolized thereby and all extensions and renewals thereof ("Trademarks");

b. any and all royalties, fees, income, payments and other proceeds now or hereafter due or payable with respect to the Trademarks; and

c. **Patent and Trademark Office**. The Administrative Agent hereby authorizes and requests that the United States Patent and Trademark Office note and record the existence of the release hereby given.

**2. Governing Law**. This Release shall be governed by, and construed in accordance with, the laws of the State of New York without giving effect to any choice or conflict of law provision or rule.




