SUPPLEMENT NO. 1 TO INTELLECTUAL PROPERTY SECURITY AGREEMENT

This Supplement No.1 to Intellectual Property Security Agreement (this “*Supplement*”) is made as of the 8th day of July, 2021, by **NETWORK FOR GOOD, INC.**, a New York corporation (“*Grantor*”) , in favor of **WESTERN ALLIANCE BANK**, an Arizona corporation (“*Lender*”).

WHEREAS, the Grantor executed and delivered an Intellectual Property Security Agreement dated as of October 26, 2020 (as amended and of record from time to time hereinafter, the “*Grant*”) in favor of the Lender, pursuant to which the Grantor granted a security interest in certain Intellectual Property Collateral (as defined therein), which was recorded on October 26, 2020 at Reel 7087 Frame 0570 in the Trademark division of the U.S. Patent and Trademark Office;

WHEREAS the Grantor desires to confirm the grant of a security interests in certain additional Intellectual Property Collateral in favor of the Lender.

NOW, THEREFORE, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:


1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Grant.
