## TRADEMARK ASSIGNMENT AGREEMENT

THIS TRADEMARK ASSIGNMENT AGREEMENT (this "Assignment") is made and entered into as of the 11th day of June, 2021, by and between BRIGGS MEDICAL SERVICE COMPANY, a Delaware corporation having its principal place of business at 4900 University Avenue, Suite 200, West Des Moines, Iowa 50266 ("BMSC"), BRIGGS MANUFACTURED PRODUCTS COMPANY, LLC, a Delaware limited liability company having its principal place of business at 4900 University Avenue, Suite 200, West Des Moines, Iowa 50266 ("BMPC"), and ASPEN SURGICAL PRODUCTS, INC., a Michigan corporation having its principal place of business at 6945 Southbelt Drive SE, Caledonia, Michigan 49316 ("Aspen"). BMSC, BMPC, and Aspen will be jointly referred to as the "Parties" and each as a "Party."

### RECITALS

A. BMSC and BMPC are the owners of the common law trademarks and the registered trademarks set forth in Section 3.15(a)(i), hereinafter, the "Stork IP Trademarks."

B. BMSC, BMPC, and Aspen have entered into an Asset Purchase Agreement (the "Purchase Agreement") on June 11, 2021 ("Effective Date"), pursuant to which BMSC and BMPC are selling certain assets to Aspen, including the Stork IP Trademarks as named in Section 3.15(a)(i).

C. In connection with the Purchase Agreement, BMSC and BMPC wish to assign to Aspen, and Aspen wishes to accept the assignment of, all right, title and interest of BMSC and BMPC in and to the Stork IP Trademarks.

NOW, THEREFORE, in consideration of the mutual promises and agreements set forth herein, and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, BMSC and BMPC each hereby agree as follows:

1. **Assignment.** BMSC hereby transfers, assigns, conveys and delivers to Aspen, as of the Effective Date, and Aspen accepts, all right, title and interest of BMSC in and to the Stork IP Trademarks owned by BMSC in Section 3.15(a)(i), including any and all: (a) goodwill symbolized thereby; (b) common law rights associated therewith; (c) all causes of action (either in law or equity), and the right to sue, counterclaim, and recover for past or future infringement or dilution with respect to the BMSC Stork IP Trademarks; and (d) rights to assign the rights conveyed herein, the same to be held and enjoyed by Aspen for its own use and benefit, and for the benefit of its successors, assigns, and legal representatives.

BMPC hereby transfers, assigns, conveys and delivers to Aspen, as of the Effective Date, and Aspen accepts, all right, title and interest of BMPC in and to the Stork IP Trademarks owned by BMPC in Section 3.15(a)(i), including any and all: (a) goodwill symbolized thereby; (b) common law rights associated therewith; (c) all causes of action (either in law or equity), and the right to sue, counterclaim, and recover for past or future infringement or dilution with respect to the BMPC Stork IP Trademarks; and (d) rights to assign the rights conveyed herein, the same to be held and enjoyed by Aspen for its own use and benefit, and for the benefit of its successors, assigns, and legal representatives.

2. **Further Assurances.** BMSC further agrees that it shall take such other similar actions as Aspen may reasonably require, at Aspen's cost, to effectively assign, convey, and transfer to Aspen the Stork IP Trademarks owned by BMSC in Section 3.15(a)(i). BMSC further agrees to communicate to Aspen or its representatives any facts known to BMSC respecting said BMSC Stork IP Trademarks and to testify in any legal proceeding, sign all lawful papers, and execute all documents related to renewal and/or enforcement of the BMSC Stork IP Trademarks.

BMPC further agrees that it shall take such other similar actions as Aspen may reasonably require, at Aspen's cost, to effectively assign, convey, and transfer to Aspen the Stork IP Trademarks owned by BMPC in Section 3.15(a)(i). BMPC further agrees to communicate to Aspen or its representatives any facts known to BMPC respecting said BMPC Stork IP Trademarks and to testify in any legal proceeding, sign all lawful papers, and execute all documents related to renewal and/or enforcement of the BMPC Stork IP Trademarks.

3. **Successors and Assigns.** This Assignment shall inure to the benefit of and is binding upon the respective successors and assigns of either BMSC or BMPC and Aspen.

4. **Governing Law.** This Assignment shall be governed by and construed in accordance with the substantive law of the State of Delaware without giving effect to the principles of conflicts of law thereof.

5. **Purchase Agreement.** This Assignment is subject to all the terms and conditions of the Purchase Agreement and its terms shall not modify the applicable terms and conditions of the Purchase Agreement.


