WHEREAS, the Security Agreement was recorded with the trademark division of the

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate,  
release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of  
which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee  
hereby states as follows:

1. Definitions. "Intellectual Property " G ® ®  
Grantor's right, title and interest of every kind and nature as of the date hereof in and to its  
general intangibles, including, without limitation, the Trademarks listed on Exhibit A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement  
and terminates, releases and discharges its security interest in all right, title and interest to the  
Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title  
and interest of Grantee in the Intellectual Property.
