## RELEASE OF SECURITY INTEREST IN TRADEMARKS

This RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), dated as of July 27, 2021 (the “Effective Date”), is made by THE HUNTINGTON NATIONAL BANK, as successor to FIRST MERIT BANK N.A., in its capacity as Administrative Agent for the Lenders (the “Agent”), in favor of WHITEBRIDGE PET BRANDS, LLC, a Delaware limited liability company (the “Grantor”).

WHEREAS, pursuant to that certain Credit and Security Agreement, dated as of February 22, 2016, by and among the Agent, the Grantor and certain other parties thereto (the “Security Agreement”), the Grantor executed and delivered a Collateral Assignment of Trademarks, dated as of February 22, 2016 (the “Trademark Security Agreement”) for recordal with the United States Patent and Trademark Office, wherein the Grantor granted to the Agent, for the benefit of the Lenders a security interest in and to all of the right, title and interest of Grantor in, to and under the Trademark Collateral (as defined therein), including without limitation those Trademarks set forth on Schedule 1;

WHEREAS, the Trademark Security Agreement was recorded with the United States Patent and Trademark Office on by August 26, 2020 at Reel 5745 Frame 0069;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Agent hereby agrees as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Security Agreement or the Trademark Security Agreement, as applicable.
2. Release. The Agent, on behalf of itself and the Lenders, hereby releases, discharges, terminates and cancels all of its security interest in the Trademark Collateral, and retransfers, re-conveys and reassigns to the Grantor free and clear of any claims by the Agent, all right, title or interest of the Agent (if any) in, to or under the Trademark Collateral, including, without limitation the trademark registrations and applications set forth on Schedule I attached hereto, arising under the Security Agreement and the Trademark Security Agreement.
3. Termination. The Agent, without representation or warranty of any kind, terminates and cancels the Trademark Security Agreement.
4. Further Assurances. The Agent agrees to take all further actions, and provide to the Grantor and their successors, assigns or other legal representatives, all such cooperation and assistance (including, without limitation, the execution and delivery of any and all documents or other instruments), reasonably requested by the Grantor, at the Grantor’s sole cost and expense, to more fully and effectively effectuate the purposes of this Release.
5. Governing Law. This Release shall be governed by, and construed and interpreted in accordance with, the law of the State of Illinois.
