**TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY  
AGREEMENT**

**THIS TERMINATION AND RELEASE OF INTELLECTUAL PROPERTY SECURITY AGREEMENT** (this "Termination"), is dated as of July 30, 2021, and made by **PNC BANK, NATIONAL ASSOCIATION** (the "Grantee"), to **ORNAMENTAL PRODUCTS, LLC**, a North Carolina limited liability company ("Ornamental Products"), **ORNAMENTAL MOULDINGS, LLC**, a Delaware limited liability company ("Ornamental Mouldings"), **THE EMPIRE COMPANY, LLC**, a Michigan limited liability company ("Empire"), and **ORNAMENTAL MOULDINGS COMPANY**, a Nova Scotia unlimited liability company ("Ornamental Mouldings Company", and together with Ornamental Products, Ornamental Mouldings and Empire, collectively the "Grantors" and each a "Grantor").

WHEREAS, pursuant to that certain Intellectual Property Security Agreement dated as of December 1, 2016, made by Grantors in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantors to Grantee in certain collateral, including the Intellectual Property (as hereinafter defined);

WHEREAS, the Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on December 8, 2016 at Reel/Frame 005958/0451;

WHEREAS, Grantee now desires to terminate the Security Agreement and terminate, release and discharge its security interest in the Intellectual Property;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Intellectual Property," as used herein, shall mean all of the Grantors' right, title and interest of every kind and nature as of the date hereof in the Intellectual Property listed on Exhibit A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Intellectual Property and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Intellectual Property.
