TRADEMARK RELEASE AND REASSIGNMENT

THIS TRADEMARK RELEASE AND REASSIGNMENT (this “Release”) is made as of June 30, 2021, by GOLUB CAPITAL LLC, as administrative agent for the Secured Parties (in such capacity, the “Grantee”), in favor of Langer Biomechanics, Inc., Arizona AFO, Inc., Apex Foot Health Industries, LLC and The Orthotic Group, Inc. (each a “Grantor” and, collectively, the “Grantors”). Capitalized terms used but not defined herein shall have the same meanings assigned to such terms in the Security Agreement (as defined below).

W I T N E S S E T H:

WHEREAS, the Grantors and Grantee entered into that certain Guaranty and Security Agreement, dated as of February 27, 2015, by and among the Grantors, the other Grantors party thereto and the Grantee (including all annexes, exhibits or schedules thereto, as amended, restated, supplemented or otherwise modified from time to time, the “Security Agreement”), each Grantor granted and pledged to the Grantee, for the benefit of the Secured Parties, a continuing security interest in all of such Grantor’s right, title and interest in and to the Collateral;

WHEREAS, certain of the Grantors and the Grantee are parties to that certain Trademark Security Agreement, dated as of February 27, 2015 (including all annexes, exhibits or schedules thereto, as amended, restated, supplemented or otherwise modified from time to time, the “First Trademark Security Agreement”) pursuant to which each such Grantor granted a security interest (the “First Security Interest”) to the Grantee, for the benefit of the Secured Parties, in the Trademark Collateral (as defined below), including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, certain of the Grantors and the Grantee are parties to that certain Trademark Security Agreement, dated as of September 3, 2020 (including all annexes, exhibits or schedules thereto, as amended, restated, supplemented or otherwise modified from time to time, the “Second Trademark Security Agreement” and, together with the First Trademark Security Agreement, the “Trademark Security Agreements”) pursuant to which each such Grantor granted a security interest (the “Second Security Interest” and, together with the First Security Interest, the “Security Interest”) to the Grantee, for the benefit of the Secured Parties, in the Trademark Collateral (as defined below), including the Trademarks set forth on Schedule 1 hereto;

WHEREAS, the First Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on March 11, 2015 at Reel 5475, Frame 0828;

WHEREAS, the Second Trademark Security Agreement was recorded by the Trademark Division of the United States Patent and Trademark Office on January 5, 2021 at Reel 7190, Frame 0764; and

WHEREAS, the Grantors have requested that Grantee release its Security interest in the Trademark Collateral and reassign any and all rights in the same to the Grantors.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. The Grantee hereby terminates each Trademark Security Agreement and terminates, releases, and discharges its Security Interest, and all of its right, title and interest in, to and under the following (collectively the “Trademark Collateral”):

(a) each Trademark and IP License owned by each Grantor providing for the grant by or to such Grantor of any right under any Trademark, including, without limitation, those referred to in Schedule 1 hereto;

(b) all renewals and extensions of the foregoing; and

(c) all goodwill of the business connection with the use of, and symbolized by, each such Trademark and all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. The Grantee hereby releases its Security Interest in the Trademark Collateral and reassigns, grants and conveys to the Grantors, without any representation, recourse or undertaking by Grantee, any and all of Grantee's right, title and interest in and to the Trademark Collateral.


