RELEASE OF ABL TRADEMARK SECURITY AGREEMENT

Release of ABL Trademark Security Agreement, dated as of August 2, 2021 by PNC Bank, National Association, as Administrative Agent (“Releasor”) to POWER PACKER NORTH AMERICA, INC., B.W. ELLIOTT MANUFACTURING CO., LLC and WEASLER ENGINEERING, INC. (collectively, the “Releasee”).

WITNESSETH:

WHEREAS, pursuant to that certain ABL Trademark Security Agreement, dated as of October 31, 2019 (the “Trademark Security Agreement”), recorded in the United States Patent and Trademark Office (“USPTO”) on November 1, 2019 under Reel/Frame 6785/0306, by Releasee to Releasor, the Releasee, to secure the payment or performance, as the case may be, in full of the Secured Obligations (as defined in the ABL Security Agreement) of the Releasee, granted to Releasor a security interest in (i) all trademarks, service marks, trade names, corporate names, trade dress, logos, designs, domain names, fictitious business names, and other source or business identifiers, then existing or thereafter adopted or acquired, all registrations and recordings thereof, and all registration and applications filed in connection therewith, including those listed on Schedule A hereto, and all extensions or renewals thereof, as well as any unregistered trademarks and service marks and (ii) all goodwill connected with the use of and symbolized thereby (collectively, the “Trademark Collateral”); and

WHEREAS, the Releasee has requested, and Releasor has agreed to execute, acknowledge and deliver, this Release of ABL Trademark Security Agreement to terminate the Trademark Security Agreement and confirm the release, relinquishment and discharge of its continuing security interest in the Trademark Collateral.

NOW, THEREFORE, in consideration of and in exchange for good and valuable consideration, including the satisfactory performance and payment in full of all the Secured Obligations of Releasee, the sufficiency and receipt of which are hereby acknowledged, Releasor hereby agrees as follows:


SECTION 1. Defined Terms. Unless otherwise defined herein, capitalized terms used herein shall have the meanings given to them in the Trademark Security Agreement.

SECTION 2. Release of Security Interest. Releasor hereby, without any representation or warranty and without any recourse to Releasor, terminates the Trademark Security Agreement and hereby terminates, releases, relinquishes and discharges its lien on and security interest in the Trademark Collateral and re-assigns and re-conveys to Releasee any and all right, title and interest Releasor may have in or to the Trademark Collateral.

SECTION 3. Governing Law. THIS RELEASE OF ABL TRADEMARK SECURITY AGREEMENT IN TRADEMARKS SHALL BE GOVERNED BY AND CONSTRUED IN ACCORDANCE WITH THE LAW OF THE STATE OF NEW YORK.
