

**Declaration**

The undersigned, Timothy D. Pecsénye, hereby declares that:

1. He is attorney for Citizens Bank, National Association, the entity currently listed as the owner of the above-identified trademarks and registrations, and is authorized to execute this Declaration on behalf of said owner.

2. The assignment recorded with the Assignment Branch of the U.S. Patent and Trademark Office at Reel/Frame 6669/0140, which applies to the above-identified marks, contains erroneous



information and was inadvertently filed under the wrong type of filing ("Improper Assignment"). Specifically, the document was inadvertently filed as a "New Assignment," but should have been filed as an "Amended Reinstated Security Interest."

3. When filing the Improper Assignment, the assignor, listed as "Citizens Bank of Pennsylvania," did not own the above-identified trademarks or registrations therefor, as the entire interest and the goodwill of the above-identified trademarks and registrations therefor were owned by Anexinet Corp.

4. As a result of the inadvertent misclassification when filing the subject document, ownership of the trademarks and registrations was improperly assigned from the rightful owner, Anexinet, Inc., to Citizens Bank, National Association.

5. Therefore, the recordal of the Improper Assignment at Reel/Frame 6669/0140 was invalid and improperly filed with the Assignment Recordation Branch of the U.S. Patent and Trademark Office and should be removed from the record.

6. Anexinet Corp., a Pennsylvania corporation, was and continues to be the correct and accurate owner of the subject marks and registrations therefor and has at all relevant times been the exclusive owner of said marks.

7. Citizens Bank, National Association, assignee and improper current owner of the above-identified marks and registrations, hereby identifies the inadvertent erroneous filing of the Improper Assignment and requests ownership of the above-

identified marks be restored to Anexinet Corp. and the Improper Assignment be removed from the record.
