**RELEASE OF FIRST LIEN SECURITY INTEREST
IN TRADEMARKS**

This RELEASE OF FIRST LIEN SECURITY INTEREST IN TRADEMARKS, dated as of August 19, 2021 (this “*Release*”), is made by UBS AG, Stamford Branch, acting through one or more of its branches or any Affiliate thereof, as Administrative Agent for the Secured Parties (the “*Administrative Agent*”) in favor of Enlighten It Consulting, LLC (the “*Grantor*”). Capitalized terms used in this Release and not otherwise defined herein have the meanings ascribed to them (explicitly or by reference) in the Trademark Security Agreement (as defined below).

WHEREAS, Grantor, the Administrative Agent and the other parties thereto executed and delivered that certain First Lien Guarantee and Collateral Agreement dated August 19, 2015 (as may have been amended, amended and restated, supplemented or otherwise modified, the “*Security Agreement*”);

WHEREAS, pursuant to the terms of the Security Agreement, the Grantor executed and delivered that certain First Lien Grant of Security Interests in Trademark Rights, dated August 22, 2018, which was recorded with the United States Patent and Trademark Office on August 28, 2018, at Reel/Frame Nos. 6436/0423 (the “*Trademark Security Agreement*”);

WHEREAS, pursuant to the Security Agreement and the Trademark Security Agreement, the Grantor pledged and granted to the Administrative Agent, for the benefit of the Administrative Agent and the Secured Parties, a continuing security interest in, and a right of setoff against (the “*Security Interest*”) all of the Grantor’s right, title and interest in, to and under the Trademarks (including, without limitation, those items listed on Schedule A hereto) (collectively, the “*Collateral*”); and

WHEREAS, the Grantor has requested the Administrative Agent to, and the Administrative Agent now desires to, terminate and release the Security Interest in the Collateral.

NOW, THEREFORE, in consideration of the foregoing and for other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Administrative Agent, without recourse, representation, warranty, promise, undertaking, statement or assurance of any kind or nature, and at the Grantor’s sole cost and expense, hereby terminates, cancels and releases the Security Interest in the Collateral, and hereby reassigns to the Grantor any right, title or interest it may have in the Collateral.




