**TERMINATION AND RELEASE OF CONFIRMATORY GRANT OF SECURITY
INTEREST IN UNITED STATES TRADEMARKS**

THIS TERMINATION AND RELEASE OF CONFIRMATORY GRANT OF SECURITY INTEREST IN UNITED STATES TRADEMARKS (this "Release"), dated this 16th day of August, 2021, is by JOHNSON BANK, whose principal address is 100 East Wisconsin Avenue, Milwaukee, Wisconsin 53202, as administrative agent for itself and certain financial institutions ("Assignee").

B. WHEREAS, Crane 1 Services, Inc., a Delaware corporation (the "Grantor"), granted Assignee a security interest the trademarks and the goodwill of the business in connection therewith (the "Trademarks") listed on Exhibit A attached hereto pursuant to a Confirmatory Grant of Security Interest in United States Trademarks dated October 7, 2015 (the "Security Agreement");

C. WHEREAS Grantor requests that the Assignee release any and all right, title, and interest in and to the Trademarks, and the Assignee agrees to release any and all such right, title, and interest.

NOW, THEREFORE, FOR VALUE RECEIVED, the Assignee agrees as follows:

1) The Assignee does hereby terminate and release the Security Agreement and its security interest in and to the Trademarks, and all rights therein of any type or description.

2) The Assignee hereby authorizes Grantor (or its authorized representative) to file copies of this Release with the USPTO, and any other document with any other filing office necessary to memorialize this Release and to extinguish the Assignee's rights and interest in the Trademarks.


3) This Release is governed by the laws of the State of Wisconsin without regard to the principles of conflicts of laws.
