**NOTICE OF ASSIGNMENT OF  
SECURITY INTEREST IN TRADEMARKS**

**This NOTICE OF ASSIGNMENT OF SECURITY INTEREST IN TRADEMARKS** (“Notice of Assignment”) dated August 13, 2021, is between BANK OF AMERICA, N.A., as retiring administrative agent (“Assignor”), and CAPITAL ONE, NATIONAL ASSOCIATION, as successor Administrative Agent for the Lenders party to that certain Second Amended and Restated Credit Agreement, dated as of January 16, 2015, as amended, restated, supplemented or otherwise modified from time to time (“Assignee”).

WHEREAS, NorthStar Alarm Services, LLC, a Utah limited liability company and NorthStar Alarm Services CA, LP, a Utah limited partnership (collectively, “Grantor”), and Assignor entered into that certain Trademark Security Agreement, dated as of May 17, 2019 (the “Trademark Security Agreement”), whereby Grantor granted to Assignor a continuing security interest in all of its right, title and interest in the trademarks and trademark applications of the Grantor, including, without limitation, each trademark and trademark application listed on Schedule I attached hereto and incorporated herein by reference.

WHEREAS, the Trademark Security Agreement was recorded in the records of the United States Patent and Trademark Office on June 25, 2019 at Reel 006677, Frame 0316.

WHEREAS, Assignor has resigned as Administrative Agent under the Trademark Security Agreement.

WHEREAS, Assignee has been appointed as successor Administrative Agent under the Trademark Security Agreement and has succeeded to all the rights, duties, authority, and responsibilities of the Administrative Agent thereunder pursuant to that certain Agency Transfer Agreement dated as of the date hereof (“Agency Transfer Agreement”), among Assignor, Assignee and the other parties thereto.

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the parties hereto agree as follows:

1. Defined Terms. All capitalized terms used, but not otherwise defined herein, shall have the respective meanings ascribed in or otherwise referenced in the Agency Transfer Agreement or the Trademark Security Agreement, as applicable.

2. Resignation and Appointment. Pursuant to the terms and conditions set forth in the Agency Transfer Agreement, the Assignor has ceased to be Administrative Agent, and is succeeded to and replaced by the Assignee as Administrative Agent, under the Trademark Security Agreement and the other Loan Documents. To the extent that any of Assignor’s right, title and interest as Administrative Agent in the Trademark Security Agreement was not validly transferred to Assignee pursuant to the Agency Transfer Agreement, Assignor hereby assigns, without representation, warranty or recourse, any and all such right, title and interest to Assignee. Furthermore, Assignor and Assignee execute this Notice of Assignment to give notice of the resignation by Assignor and the acceptance by Assignee of all of Assignor’s right, title and interest as Administrative Agent in the Trademark Security Agreement.

Nothing herein shall be deemed to terminate, interrupt or impair the continuity of the security interest in the collateral originally granted to the Assignor under the Trademark Security Agreement, which security interest is now succeeded by, assigned and transferred to the Assignee.




