TERMINATION AND RELEASE OF SECURITY INTEREST
IN TRADEMARKS

This TERMINATION AND RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “Release”), is made as of September 1, 2021, by Bank of America, N.A. (“Bank of America”), as collateral agent for the First Lien Secured Parties under the security agreement referenced below (in such capacity, the “Collateral Agent”), in favor of PatientKeeper, Inc. (the “Grantor”) with respect to the Trademarks (as defined below).

W I T N E S S E T H :

WHEREAS, Grantor is a party to the First Lien Security Agreement dated as of November 17, 2006 in favor of the Collateral Agent (together with all amendments, modifications and supplements, if any, from time to time thereafter made thereto, the “First Lien Security Agreement”);

WHEREAS, pursuant to the First Lien Security Agreement, the Collateral Agent and Grantor entered into a Grant of Security Interest in Trademark Rights on November 9, 2015, which was recorded with the U.S. Patent and Trademark Office (the “USPTO”) on November 10, 2015, which was at Reel 5665 Frame 0641, a Grant of Security Interest in Trademark Rights on December 21, 2018, which was recorded with the USPTO on December 21, 2018, which was at Reel 6508 Frame 0319 and a Grant of Security Interest in Trademark Rights on August 17, 2020, which was recorded with the USPTO on August 24, 2020, which was at Reel 7032 Frame 0037 (collectively, the “Trademark Security Agreements”);

WHEREAS, pursuant to the Trademark Security Agreements, the Collateral Agent received security interests in all of Grantor’s rights, titles and interests in to and under all of its then currently owned or thereafter acquired United States trademarks, registrations of trademarks and applications for registration and all goodwill of the business connected with the use of and symbolized by the foregoing, including, without limitation, those United States trademark registrations and applications for trademark registrations set forth on Schedule A hereto (hereinafter all of the foregoing trademarks, trademark registrations and applications for trademark registrations together with the goodwill of the business connected with the use of and symbolized by the foregoing, collectively, the “Trademarks”);

WHEREAS, the Collateral Agent desires to release any and all security interests, and any other lien, arising under the Trademark Security Agreements in and to the Trademarks to Grantor.


NOW THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

1. The Collateral Agent hereby, without representation or warranty of any kind, absolutely, unconditionally and irrevocably releases, terminates and forever discharges each security interest in the Trademarks that was granted to the Collateral Agent under the Trademark Security Agreements, and any and all other security interests or liens that the Collateral Agent or its successors and assigns (in their respective capacity as Collateral Agent) may have in or to the Trademarks under the Trademark Security Agreements.
2. The Collateral Agent acknowledges and agrees that the Trademark Security Agreements are hereby terminated.
3. The parties hereto authorize and request the Director of Patents and Trademarks of the United States of America to record this Release against the Trademarks. Bank of America agrees to perform all further acts and execute and deliver all further documents and/or instruments that may be reasonably necessary to carry out the provisions of this Release, all at Grantor's reasonable request and at the sole cost and expense of Grantor.
4. This Release shall be governed by and construed in accordance with the law of the State of New York.
