## FIRST SUPPLEMENT TO TRADEMARK SECURITY AGREEMENT

This First Supplement to Trademark Security Agreement (this "Trademark Security Agreement") dated as of September 13, 2021 by Aquity Solutions, LLC ("Grantor"), is in favor of Citizens Bank, N.A., as administrative agent (in such capacity, the "Agent") for the itself and any other financial institution which is or becomes a party hereto.

**WHEREAS**, the Grantor executed and delivered a Trademark Security Agreement, dated as of August 14, 2019 and recorded on August 15, 2019 at Reel 6720, Frame 0800 (as amended of record from time to time hereinafter, the "Existing Trademark Security Agreement") in favor of the Agent, pursuant to which the Grantor pledged, assigned and granted a security interest in certain trademarks and trademark applications (the "Marks"); and

**WHEREAS**, Grantor developed additional Marks and desires to hereby confirm the pledge of, and the grant of a security interest in, such additional Marks in favor of the Agent; and


**NOW, THEREFORE**, in consideration of the mutual covenants herein contained and benefits to be derived herefrom, it is hereby agreed as follows:

1. Definitions. All capitalized terms herein and not otherwise defined shall have the same meaning herein as in the Existing Trademark Security Agreement.
2. Supplement to Exhibit A. Exhibit A to the Existing Trademark Security Agreement is hereby supplemented, but not replaced, by Exhibit 1-A annexed hereto.
3. Miscellaneous:
  - a. Except as provided herein, all terms and conditions of the Existing Trademark Security Agreement remain in full force and effect. The Grantor hereby ratifies, confirms and reaffirms all of the representations, warranties and covenants contained therein.
  - b. This Trademark Security Agreement covers the entire understanding of the parties with respect to the matters set forth herein and supersedes all prior discussions and negotiations hereon.
