RELEASE OF SECURITY INTEREST IN TRADEMARKS

This Release of Security Interest in Trademarks (this “Release”) is effective as of September 17, 2021, by PNC BANK, NATIONAL ASSOCIATION (“Agent”) in favor of FUNKO GAMES, LLC (f/k/a Forrest-Pruzan Creative, LLC), a limited liability company organized under the laws of the State of Washington (“Grantor”). Capitalized terms used but not otherwise defined herein have the meaning given to them in the Security Agreement (as defined below).

WHEREAS, the Grantor entered into a Security Agreement Supplement, dated as of March 22, 2019, under which it became a party to that certain Pledge and Security Agreement, dated October 22, 2018 (as amended, restated, supplemented, modified or otherwise changed from time to time, the “Security Agreement”), in favor of Agent.

WHEREAS, pursuant to the Security Agreement, Grantor executed that certain Grant of a Security Interest - Trademarks, dated as of March 22, 2019, in favor of Agent (as amended, restated, amended and restated, supplemented or otherwise modified from time to time, the “Trademark Security Agreement”), whereby Grantor granted to Agent a continuing security interest in all of the IP Collateral (as such term is defined in the Trademark Security Agreement) of Grantor, including, without limitation, the Trademarks (as defined in the Trademark Security Agreement) listed on Exhibit A hereto, to secure the prompt payment, performance and observance of the Secured Obligations (as defined in the Security Agreement);

WHEREAS, the Trademark Security Agreement was recorded with the trademark division of the United States Patent and Trademark Office on December 11, 2019 at Reel/Frame 6819/0724; and


WHEREAS, the Grantor has requested that the Agent release its security interest in all right, title and interest in, to and under all of the IP Collateral and Agent desires to release its security interest in all right, title and interest in, to and under all of the IP Collateral.

NOW, THEREFORE, intending to be legally bound hereby and in connection with the Trademark Security Agreement, Agent hereby (i) releases the continuing security interest and continuing lien upon, and terminates its security interest in, and all other rights, title and interest in and to, the IP Collateral (as defined in the Trademark Security Agreement) including, without limitation, the Trademarks (as defined in the Trademark Security Agreement) listed on Exhibit A hereto, without any recourse, representation or warranty, (ii) terminates the Trademark Security Agreement, and (iii) re-assigns to Grantor, any right, title or interest Agent may have in, to or under the IP Collateral under the Security Agreement or the Trademark Security Agreement, together with the goodwill of the business symbolized thereby, and hereby authorizes Grantor or Grantor’s authorized representative or designee to record this Release with the United States Patent and Trademark Office as evidence of such release and termination.
