**RELEASE OF TRADEMARK SECURITY INTEREST  
(Term Loan A)**

THIS RELEASE OF TRADEMARK SECURITY INTEREST (this “Release”) is made as of January 18, 2019 (the “Effective Date”) in favor of Longyear TM, Inc. (the “Grantor”) by Wilmington Trust, National Association, as Collateral Agent pursuant to the Term Loan A Security Agreement referred to below (in such capacity, the “Collateral Agent”).

WHEREAS, pursuant to the terms and conditions of that certain U.S. Pledge and Security Agreement dated as of October 22, 2014 (as amended, restated, supplemented or otherwise modified from time to time, the “Term Loan A Security Agreement”) and executed and delivered pursuant to that certain Term Loan A Securities Agreement dated as of October 22, 2014 among Boart Longyear Management Pty Limited, as issuer, the guarantors named therein (including the Grantor), the purchasers named therein, and Wilmington Trust, National Association, as agent (as amended, restated, supplemented or otherwise modified from time to time, the “Term Loan A Securities Agreement”), the Grantor granted in favor of the Collateral Agent a security interest in and to the Grantor’s Trademarks and Trademark applications, including its entire rights, interests and title in, to, and under the trademark registrations and Trademark applications, and the goodwill associated therewith set forth on Exhibit A hereto (together with all Proceeds of such registrations, applications, or goodwill, the “Trademark Collateral”);

WHEREAS, Trademark Security Agreements evidencing the Trademark Collateral were recorded with the United States Patent and Trademark Office at Reel 5390 and Frame 0087 recorded on October 29, 2014; Reel 5668 and Frame 0820 recorded on November 16, 2015; Reel 5850 and Frame 0332 recorded on July 15, 2016; Reel 5920 and Frame 0496 recorded on November 15, 2016; Reel 6104 and Frame 0516 recorded on July 13, 2017; Reel 6367 and Frame 0043 recorded on May 1, 2018; and Reel 6441 and Frame 0516 recorded on September 20, 2018, which are set forth on Exhibit A;

WHEREAS, the terms and conditions of the Term Loan A Securities Agreement have been fulfilled, and the Collateral Agent now hereby releases its security interest in the Trademark Collateral set forth on Exhibit A;

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby covenants and agrees as follows:

1. All capitalized terms used but not otherwise defined herein have the meanings given to them in the Security Agreement.
2. Collateral Agent hereby irrevocably and unconditionally terminates and releases (i) its lien on and security interest in the Trademark Collateral, and (ii) each of the Trademark Security Agreements referenced in the recitals.
3. The Collateral Agent hereby authorizes the filing, without further notice, of this Release and any termination that is necessary to release the Trademark Collateral, at the United


States Patent and Trademark Office and any comparable office outside the United States by the Grantor (or the Grantor's designee), at the Grantor's sole cost and expense. The Collateral Agent hereby agrees to execute, acknowledge and deliver to the Grantor all such further instruments and to take all such further actions as may be reasonably requested or are required in order to more fully and effectively carry out the purposes of this Release.

4. For avoidance of doubt, nothing contained in this Release shall be construed to release, reconvey or otherwise transfer, or terminate, (i) the security interests or liens in any of the Trademark Collateral granted by the Grantor in favor of Wilmington Trust, National Association, in its capacity as collateral agent pursuant to that certain U.S. Pledge and Security Agreement dated as of December 31, 2018 and executed and delivered pursuant to the Term Loan A Securities Agreement or Term Loan B Securities Agreement, each dated as of December 31, 2018 among BL Capital Management LLC, as issuer, the guarantors named therein (including the Grantor), the purchasers named therein, and Wilmington Trust, National Association, as agent, or (ii) the Trademark Security Agreement, dated as of December 31, 2018, by the Grantor in favor of Wilmington Trust, National Association, executed pursuant to such Term Loan A Securities Agreement or Term Loan B Securities Agreement, or the security interests and liens granted thereunder.
