**RELEASE OF SECURITY INTEREST IN TRADEMARKS**

THIS RELEASE OF SECURITY INTEREST IN TRADEMARKS (this “**Release**”) is made as of the October 5, 2021, by PNC BANK, NATIONAL ASSOCIATION, in its capacity as agent for the Lenders (together with its successors and assigns in such capacity, “**Agent**”), for the benefit of EMCOR ENCLOSURES, LLC, a Delaware limited liability company (“**Grantor**”).

WHEREAS, pursuant to that certain Trademark Security Agreement dated as of November 1, 2019 (the “**Trademark Agreement**”; all terms capitalized but not otherwise defined herein shall have the meanings herein as defined in the Trademark Agreement), Grantor granted, assigned, and pledged to Agent, for the benefit of the Lenders, a security interest in all of Grantor’s right, title and interest in and to the Trademark Collateral (as defined in the Trademark Agreement) identified on Exhibit A attached hereto (the “**Released Trademarks**”); provided, however, Released Trademarks shall not include any Trademark Collateral owned by CRENLO CAB PRODUCTS, LLC, a Delaware limited liability company;

WHEREAS, the Trademark Agreement was recorded in the Trademark Division of the United States Patent and Trademark Office on November 3, 2019, at Reel 6786 and Frame 0107; and

WHEREAS, the Agent has agreed to release its security interest in the Released Trademarks.

NOW, THEREFORE, for valuable consideration:

The Agent hereby terminates and releases its security interest in the Released Trademarks, and the Agent hereby assigns and transfers to Grantor, without any representation, warranty, or recourse whatsoever, the Agent’s entire right, title, and interest in and to the Released Trademarks, effective as of the date set forth above.


Any such signature delivered by a party by facsimile or electronic transmission (including email transmission of a PDF image) shall be deemed to be an original signature hereto.

THIS RELEASE SHALL BE SUBJECT TO THE PROVISIONS REGARDING CHOICE OF LAW, JURISDICTION AND VENUE SET FORTH IN SECTION 16.1 OF THE CREDIT AGREEMENT (AS DEFINED IN THE TRADEMARK AGREEMENT), AND SUCH PROVISIONS ARE INCORPORATED HEREIN BY THIS REFERENCE, MUTATIS MUTANDIS.
