**RELEASE OF SECURITY INTEREST  
IN TRADEMARK RIGHTS**

Grantee, without recourse, representation or warranty, absolutely and unconditionally terminates, cancels, discharges and releases any and all security interests it has against the Additional Trademarks pursuant to any of the Security Agreements referenced in the 2019 Release or otherwise.


