**TERMINATION AND RELEASE OF CONFIRMATORY GRANT OF SECURITY  
INTEREST IN UNITED STATES PATENTS, TRADEMARKS, AND COPYRIGHTS**

4) This Release shall be binding upon the Assignee and its successors and assigns and inures to the benefit of Grantor and its successors and assigns.
